There was a strong odor of ingested alcohol coming from the defendant's breath, his eyes were bloodshot and watery, his speech was slurred, and his balance was impaired. The defendant was drawn from the rest of the crowd and placed in handcuffs. He resisted as he was being placed in handcuffs and he refused to get into the backseat of the squad car. Officer Rea administered a drive stun to the defendants left leg with her Tazer in an effort to get him to comply with orders. The defendant was argumentative throughout my entire interaction with him. The above information is probable cause to constitute the charge of Interference with Official Acts.

State all facts and persons relied upon supporting elements of alleged crime _____

On 03/26/17 at approximately 0056 hours your affiant responded to a disorderly at Sharkys (2223 College St.) in Cedar Falls, IA. During the altercation the crowd became hostile and belligerent towards officers. A friend of the Defendant's had been arrested. During this

arrest the Defendant was attempting to grab his friend even when officers told him to get back. Once the co-Defendant was removed from the scene the Defendant came at your affiant yelling and waving his arms in a threatening manner. Your affiant answered the Defendant's questions and instructed him to stay on the sidewalk. The Defendant then went aggressively towards a second officer who instructed him to get back on the sidewalk. The Defendant then went to a third uniformed Officer who felt threatened by his demeanor and pulled his ASP baton out. The Defendant was yelling, and using profanity at all of the officers. The Defendant was admittedly "jacked up" on adrenaline. The Defendant was placed under arrest and charged with Interference with Official Acts, a simple misdemeanor.
