WRIT GRANTED AND MADE PEREMPTORY. Although we find, under the facts of the instant case, that the trial court has subject matter jurisdiction over the injunctive relief sought by the Plaintiff-Respondent, Alan W. Stokes, we find that the trial court erred in granting the temporary restraining order on the merits. Although Mr. Stokes contends that the Defendants-Relators, the City of Alexandria and Jacques Roy, Mayor of Alexandria, are investigating Mr. Stokes' actions in his capacity as Chairman of the Alexandria Municipal Fire and Police Civil Service Board (the Board), we find no support for this statement in the Petition for Temporary Restraining Order and Preliminary and Permanent Injunction or the memorandum submitted in support of same. Additionally, we find these documents to be absent of any factual support for the allegation that the actions sought to be enjoined are being undertaken in an effort to harass or intimidate Mr. Stokes. Therefore, we hereby set aside the TRO. Finding no basis set forth in the pleading for the relief sought, we additionally set aside the hearing on the preliminary injunction set for Monday, June 25, 2018, and enter judgment dismissing the petition for injunctive relief.
