**Count 1**

THE DEFENDANT is accused of the crime of **CHILD ENDANGERMENT CAUSING BODILY INJURY**, in violation of Section(s) **726.6(1)(a), 726.6(3), 726.6(6)**, Code of Iowa. For that the said defendant did on or about **March 11, 2018** in Linn County and State of Iowa,

**knowingly act in a manner that created a substantial risk to her minor son, G.T.'s physical, mental or emotional health and safety and causing the child bodily injury by driving a vehicle with the child inside into the freezing waters of the Cedar River at Mohawk Park near the intersection of J Avenue and Longbluff Road NE, Cedar Rapids, Linn County, Iowa.**

**Count 2**

THE DEFENDANT is accused of the crime of **CHILD ENDANGERMENT CAUSING BODILY INJURY**, in violation of Section(s) **726.6(1)(a), 726.6(3), 726.6(6)**, Code of Iowa. For that the said defendant did on or about **March 11, 2018** in Linn County and State of Iowa,

**knowingly act in a manner that created a substantial risk to her minor son, M.D.'s physical, mental or emotional health and safety and causing the child bodily injury by driving a vehicle with the child inside into the freezing waters of the Cedar River at Mohawk Park near the intersection of J Avenue and Longbluff Road NE, Cedar Rapids, Linn County, Iowa.**

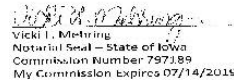
I, the undersigned, complainant, being first duly sworn on oath, depose and I believe the above-named defendant committed the above-named public offense based upon the following facts:

**Alicia Cole is the mother of minor son, G.T and minor son, M.D. Cole intentionally drove her vehicle into the Cedar River while her two children were passengers. All three subjects were exposed to potential hypothermia and drowning and had to be rescued by boaters that were on the river at the time. M.D. sustained a contusion to his head and G.T. reported abdominal pain as a result of the crash. This occurred at Mohawk Park which is located at J Ave and Longbluff Road NE, Cedar Rapids Iowa 52402.**
