WARRANT FOR DISTRAINT

TO: Colorado Department of Revenue Tax Compliance Agent or County Sheriff:

WHEREAS, in pursuance of the provisions of the laws of the State of Colorado, relating to revenue, the person below is, or are, liable to pay the license fees, tax or taxes assessed against him or them, in the amount or amount named herein below, together with the penalties and interest prescribed by law for failure to pay said license fees, tax or taxes when the same became due;

AND WHEREAS, the time provided by law for payment of the amount due has elapsed since notice was served and demand made upon said person or persons for payment of said license fees, tax or taxes, AND WHEREAS said person or persons still neglect or refuse to pay the same,

NOW THEREFORE, YOU ARE HEREBY COMMANDED to levy upon, by distraint, and to sell so much of the goods, chattels, effects, or other property or rights to property, including stocks, securities and evidences of debt, of the person or persons liable for the payment of license fees, tax or taxes assessed against them as set forth in the statement below, or on which a lien exists for license fees, tax or taxes, as may be necessary to satisfy the license fees, tax or tax rates, with such additional amount of interest, penalties, fees, costs and expenses of this levy.

If the taxpayer named herein is the owner of real property and election is made to proceed against the said real property in lieu of distraint upon personal property of the said taxpayer, you are hereby commanded to comply with statutory provisions to secure judgment and make proper filings as required by law, and to levy upon, distraint, and sell in the manner prescribed by law, such real property of the taxpayer and to apply the proceeds from said sale to the payment of the amount set forth herein and to the costs of such levy, execution and sale.

You will do all things necessary to be done in the premise and strictly comply with all requirements of law, and for so doing this shall be your warrant and thereupon to make due return to me at this office forthwith.

In accordance with the laws of this state, the amount set forth in the statement below is subject to the continuing accrual of interest until such time as this warrant is satisfied. Therefore, the specific amount of delinquent taxes and/or fees, including penalty and interest, due and payable after the date of this issuance shall be as reflected in the official accounting records of the Department of Revenue.
