Narcotics Suppression Arrests

The Carson City Sheriff's Special Enforcement Team (SET), with the assistance from multiple agencies to include, The Department of Public Safety Tri Net Narcotics task force, the Lyon County Sheriff's Office Special Investigation Unit (SIU), and the Reno Police Department Street Enforcement Team (SET) conducted a month long narcotics suppression activity targeting those using and selling narcotics in the Carson City area. During this suppression operation 23 people were arrested during 7 search warrants at different locations within the City. The suppression operation resulted in the seizure of 13.5 ounces of Methamphetamine, 4 ounces of Heroin, 245 prescription pills, 2 ounces of cocaine and 12 firearms. Two vehicles and almost \$7,000 in cash was seized during this operation period.
