#### FALSE PRETENSES TO OBTAIN MONEY LESS THAN \$650

(Misdemeanor – NRS 205.380(1)(b))

That the Defendant, Wilbur Ernesto Martinez-Guzman, on or about January 14, 2019, at Carson Township, in Carson City, State of Nevada, did knowingly and designedly, by a false pretense, obtain money from another person, with the intent to cheat or defraud the other person, in the manner following: the Defendant obtained \$33.00 by pawning or selling stolen silver rings, toe rings and turquoise rings, belonging to Connie Koontz, falsely representing that he had the legal authority to pawn or sell the property, all of which occurred at or near 601 North Carson Street, Carson City, Nevada.

#### Count XXXVI

#### FALSE PRETENSES TO OBTAIN MONEY LESS THAN \$650

(Misdemeanor – NRS 205.380(1)(b))

That the Defendant, Wilbur Ernesto Martinez-Guzman, on or about January 17, 2019, at Carson Township, in Carson City, State of Nevada, did knowingly and designedly, by a false pretense, obtain money from another person, with the intent to cheat or defraud the other person, in the manner following: the Defendant obtained \$126.00 by pawning or selling a stolen Elks ring with a blue stone, engraved with the initiates JD and the date 12-25-74, belonging to Gerald David, falsely representing that he had the legal authority to pawn or sell the property, all of which occurred at or near 601 North Carson Street, Carson City, Nevada.
