

AFFIDAVIT OF PROBABLE CAUSE FOR ARREST

**THE STATE OF TEXAS }

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF TEXAS

Before me, the undersigned authority, on this day personally appeared Deputy Mitchell Garcia known to me to be a credible person and being a Peace Officer under the laws of Texas and being duly sworn, upon oath deposes and says he/she has good reason to believe and does believe that **David Ward Beebe, DOB [REDACTED] TXDL [REDACTED]** on or about the 9th day of October, 2016, A.D. committed the offense of **PUBLIC INTOXICATION PC. 49.02** Against the peace and dignity of the state.

Afiant has personal knowledge of the following facts:

Affiant has good reason to believe and does believe based on the information provided by XXXX(a witness), a credible person who personally observed such offense as follows:

This offense occurred in Presidio County, Texas.

On Saturday at approximately 12:16 A.M. I was parked in the south end of the parking lot of the Stripes Convenience Store located at 109 E San Antonio St. I observed a male subject walking westbound into the west side of the parking lot to have poor balance as he walked. He was walking and carrying a case of beer. He stumbled/tripped and lost his balance. He continued walking in the direction northerly bound towards the St George Hotel.

As I was watching him a Texas Department of Public Safety Patrol car pulled up next to me and I asked the trooper if he had seen the subject. He replied he did. He then began driving in the direction of the male subject. Once again the male who was walking had poor balance. As the male walked westbound into the alley he tripped and almost fell, still carrying the case of beer.

I followed the trooper as he pulled behind the subject and saw them make contact. One trooper comes back to the rear of his patrol vehicle and makes a phone call. At the time I recognized the male subject as **David Beebe** the Justice of the Peace PCT 1. I could see the trooper on his cell phone. He told me that he had placed a call to his sergeant and he said he was advised to walk away. I was told they would relocate behind me and they would back me up.

I advised the trooper that Beebe was intoxicated and he agreed. I then approached Beebe and I then could smell a strong smell of an alcoholic beverage on his person. He also had blood shot eyes. I told him he was under arrest for public intoxication. I handcuffed him in the front.

As I escorted him to my patrol vehicle he continued to have poor balance. As he was getting into my patrol vehicle he lost his balance once again.

I advised Presidio County Dispatcher I was 10-95 one time with an intoxicated subject.

While being transported Beebe stated he knew this was going to happen, and that this was going to be a good newspaper story and he said that I was doing a good job for Danny.

David Beebe was intoxicated in a public place while intoxicated to a degree that the person may endanger himself or another. He was arrested PC 49.02 Public Intoxication and transported to the Presidio County Jail for Booking.

He was turned over to correction officer without incident.
