Affiant has reason to believe and does believe that <u>Lynch</u>, <u>Robert Kevin W/M DOB 10/27/62</u> committed the offense of <u>CRUELTY TO ANIMALS-KILLING a STATE JAIL FELONY</u>. The Affiant's basis of belief is the following set of facts and circumstances:

- 1. On 12/20/16 Officer Sammy Eason was dispatched to #1 Casa Loma Drive Odessa, Ector County, Texas in reference to a cruelty to non-livestock animal.
- 2. Upon arrival Officer Eason contacted the victim, Chay Pham A/N/M DOB 7/8/69, who advised a known person to them had poisoned their large Great Pyrenees dog, named Yuki by giving the dog clumps of raw meat mixed with dog food, raisins and an unidentifiable white substance.
- 3. Suspect was later identified by neighbors' and victim as Lynch, Robert Kevin W/M DOB 10/27/62.
- 4. On 12/21/16 the victim submitted paperwork from Angel Veterinary Clinic, where the victim took Yuki for medical attention. The victim also submitted surveillance video, which depicted Lynch throwing an unknown substance into their enclosed backyard on 12/18/16 at approximately 2307 hrs.
- Toxicology report from the Angel Veterinary Clinic showed that Yuki had insecticides toxicity, rodent poison toxicity, NSAID toxicity, grape toxicity, antifreeze toxicity, and GI inflammation, which is indicative of poisonous substances used to poison animals. Yuki passed away from its injuries on 12/29/16.
- Lynch was observed on surveillance video feeding the animals an unknown substance. Lynch
  voluntary confessed to poisoning the dogs with raw meat mixed with Advil, Antifreeze, rodent
  poison and raisins.
- Lynch intentionally and knowingly killed an animal, namely "Yuki" a Great Pyranese-German Shepard mix belonging to Chay Pham, without legal authority and without the effective consent of the Complainant.

WHEREFORE, Affiant asks for issuance of an Arrest Warrant, Lynch, Robert Kevin W/M DOB 10/27/62 committed the offense of CRUELTY TO ANIMALS-KILLING a STATE JAIL FELONY. THE STATE OF TEXAS COUNTY OF ECTOR
