**AFFIDAVIT TO ANY FACT**


**CASE: 16-0028998**

Affiant has reason to believe and does believe that **Lynch, Robert Kevin W/M DOB 10/27/62** committed the offense of **CRUELTY TO ANIMALS-KILLING a STATE JAIL FELONY**. The Affiant's basis of belief is the following set of facts and circumstances:

1. 12/26/16 at approximately 1305 hours, Officer Rowel Franco was dispatched to #1 Casa Loma Drive Odessa, Ector County, Texas in reference to cruelty to non-livestock animals.
2. Upon arrival Officer Franco contacted the victim, Jenny Pham W/F DOB 11/3/96, who reported a known person had again fed her dogs poisoned food, which is a large Great Pyrenees-German Sheppard mix named Brownie as well as her smaller dog that is a Yorki-Chihuahua mix named Zoey. The substance fed to the dogs was clumps of raw meat mixed with black pellets, raisins and unknown white substance.
3. On 12/26/16 surveillance video was collected by Officers, which showed a male subject walking up to the victim's enclosed backyard fence from across the alleyway, looks over the fence and then throw an unknown substance into the backyard after making a calling gesture to the dogs.
4. Upon reviewing said surveillance footage, the suspect was positively identified as being one in the same person as Lynch, Robert Kevin W/M DOB 10/27/62, which was verified upon a photo driver's license check on Mr. Lynch as well as photographs from Mr. Lynch's Facebook account.
5. Lynch was observed on surveillance video feeding the animals an unknown substance. Lynch voluntary confessed to poisoning the dogs with raw meat mixed with Advil, Antifreeze, rodent poison and raisins. Brownie passed away from its injuries on 12/26/16. Zoey had suffered serious bodily injury, and survived its injuries to this date.
6. Lynch intentionally and knowingly killed an animal, namely "Brownie" a Great Pyranese-German Shepard mix belonging to Jenny Pham, without legal authority and without the effective consent of the Complainant.

WHEREFORE, Affiant asks for issuance of an Arrest Warrant, **Lynch, Robert Kevin W/M DOB 10/27/62** committed the offense of **CRUELTY TO ANIMALS-KILLING a STATE JAIL FELONY**. THE STATE OF TEXAS COUNTY OF ECTOR

'COMPLAINT'


IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:
