INDICTMENT

IN THE NAME AND BY AUTHORITY OF THE STATE OF TEXAS:

The duly organized GRAND JURY of Ector County, Texas presents in the District Court of Ector County, Texas, that in Ector County, Texas, ELIZABETH GRACE MCDONALD, hereafter styled the defendant, heretofore on or about the, on this the 2nd day of March, 2016, did then and there intentionally and knowingly cause the death of an individual, namely, JAMES GREGORY MCDONALD, by shooting JAMES GREGORY MCDONALD with a deadly weapon, to wit: a firearm, and did then and there intentionally and knowingly cause the death of another individual, namely, JANA LOU McDonald, by shooting JANA LOU MCDONALD with a deadly weapon, to wit: a firearm, and both murders were committed during the same criminal transaction,

COUNT TWO

The duly organized GRAND JURY of Ector County, Texas presents in the District Court of Ector County, Texas, that in Ector County, Texas, ELIZABETH GRACE MCDONALD, hereafter styled the defendant, heretofore on or about the 2nd day of March, 2016, did

then and there, with the intent that murder, a felony, be committed, agree with JAMES GABRIEL MCDONALD that one of them would engage in conduct that would constitute said offense, to-wit: the shooting of JAMES GREGORY MCDONALD and JANA LOU MCDONALD with a deadly weapon, to wit: a firearm, and JAMES GABRIEL MCDONALD performed an overt act in pursuance of said agreement, to-wit: shooting JAMES GREGORY MCDONALD and JANA LOU MCDONALD with a deadly weapon, to wit: a firearm.

And the Grand Jurors aforesaid do further present that the offenses alleged above arose out of the same criminal episode.
