

CHRIS: GOOD EVENING AND WELCOME TO POINT OF VIEW. I AM CHRIS BERG. THANK YOU SO MUCH FOR JOINING US ON THIS FRIDAY EVENING. FUN FRIDAY NEWS TO START WITH. IT'S OFFICIAL KID ROCK IS YES, RUNNING FOR U. S. SENATE IN MICHIGAN. IMAGINE THIS FOR A MOMENT, YOU COULD HAVE KID ROCK DEBATING DEBBIE STABENOW, HOW GREAT IS THAT? AT THE TOP OF MY FACEBOOK PAGE JOHN PUT UP A POST THE COLLEGE ASSIGNS JOHN RICHMAN. . . BY CELEBRATING HIGH SCHOOL EDUCATION YOU ARE CELEBRATED ENOUGH TO BE A WARD OF THE STATE. I WAS PRETTY TAKEN ABACK BY THE POST. I CALLED UP JOHN TO CONFIRM THIS HAPPENED AND HE TOLD ME IT ACTUALLY DID. FIRST, TO GIVE YOU CONTEXT PRESIDENT RICHMAN WAS ON THE NEED TO KNOW SHOW. PRESIDENT RICHMAN APPARENTLY SAID TO MR. HOLMSTROM, I THINK WE SHOULD STOP CELEBRATING HIGH SCHOOL GRADUATION. STEVE ASKED HIM ABOUT IT. PRESIDENT RICHMAN SAID YOU TOLD ME YOU WOULDN'T REMEMBER THAT AND YOU DID. ACCORDING TO THINK TANKS. . .

TODAY TO BE A CONTRIBUTING MEMBER OF SOCIETY YOU NEED ALMOST AN ASSOCIATE DEGREE. THAT IS WHAT IT REQUIRES TO BE A CONTRIBUTING MEMBER OF SOCIETY. SO WE ARE CELEBRATING HIGH SCHOOL GRADUATION AND CELEBRATING YOU NOW HAVE ENOUGH EDUCATION TO BE A WARD OF THE STATE. CHRIS: A WARD OF THE STATE. I WOULD ENCOURAGE YOU TO LOOK UP THE DEFINITION OF WARD OF THE STATE TO GIVE YOU CLARITY. JOINING ME NOW IS JOHN. . . A WARD OF THE STATE, MAYBE ACCORDING TO RICHMAN?

THAT'S WHAT THEY ARE TELLING ME, I GUESS. CHRIS: YOUR TAKE ON THAT COMMENT?

I THINK IT'S UNFORTUNATE. I THINK IT PUNCTUATES A GREATER PROBLEM IN SOCIETY RIGHT NOW IN THAT MAYBE IN SOME SMALL SENSE HE'S RIGHT BECAUSE I THINK WHAT'S HAPPENING RIGHT NOW WE ARE FAILING OUR KIDS IN PUBLIC EDUCATION. I THINK WE ARE FAILING OUR KIDS IN THEIR 12TH GRADE EDUCATION. I THINK IT'S LESS PREVALENT IN FARGO, NORTH DAKOTA THAN WASHINGTON D. C. LET'S ROLL BACK THE CLOCK 100 YEARS AND LOOK AT AN EIGHTH GRADE COMPETENCE EXAM AND LOOK AT THE QUESTIONS ON THERE. MOST EIGHTH GRADERS TODAY COULDN'T ANSWER THOSE QUESTIONS. MAYBE THERE'S COLLUSION BETWEEN HIGH SCHOOL AND COLLEGE. THEY DON'T TEACH THEM ABOUT MONEY MANAGEMENT OR FISCAL COMPETENCE. THE PREDATORY COLLEGE PRESIDENTS LIKE MR. RICHMAN CAN SAY WE HAVE YOUR LOAN TAKEN CARE OF. YOU DON'T HAVE TO WORRY ABOUT THAT. WE WILL PUT YOU THROUGH SCHOOL AND WHEN YOU ARE DONE, YOU WILL BE A CONTRIBUTING MEMBER OF SOCIETY. CHRIS: I LIKE DR. RICHMAN. I KNOW HIM. I PLAYED THE CLIP FOR PEOPLE IN THE OFFICE. TWO WERE TAKEN ABACK AND TWO WERE LIKE, I TOTALLY AGREE WITH HIM. I THINK RIGHT NOW LIKE YOU HAD WE ARE FAILING OUR KIDS. TO BE FAIR TO DR. RICHMAN I AM GOING OUT TO TALK TO ALL THESE THINK TANKS WHAT THEY ARE SUGGESTING IF YOU WANT TO BE A CONTRIBUTING MEMBER OF SOCIETY, YOU NEED AN ASSOCIATE'S DEGREE.

I WOULD DISAGREE WITH THAT. YOU NEED COMMON SENSE AND PARENTS THAT CARE ABOUT YOU. I THINK COLLEGE IS A GOOD THING. UNFORTUNATELY COLLEGE IS THE ONLY BUSINESS WHO PROVIDES NO RECOURSE FOR ITS CUSTOMERS. . . CHRIS: EXCEPT FOR THE TRUMP UNIVERSITY.

[LAUGHTER]. I THOUGHT YOU WERE GOING TO HAVE MORE. SORRY ABOUT THAT. CHRIS: THAT'S OKAY. I CAN UNDERSTAND IF DR. RICHMAN SAYS GO TO COLLEGE. YOU WILL HAVE A BETTER OPPORTUNITY TO MAKE MORE MONEY. TO USE WARD OF THE STATE, THE COURT MAY TAKE RESPONSIBILITY OF AN INDIVIDUAL USUALLY A CHILD

OR INCAPACITATED PERSON. TO ALLUDE SOMEBODY WHO HAS A HIGH SCHOOL DEGREE EQUATES TO INCAPACITATED PERSON. . .

I AM A WARD OF THE STATE. YOU HAVE COLLEGE PRESIDENTS ESSENTIALLY TRYING TO SHAME PEOPLE TO GO TO COLLEGE. THAT'S NOT AN INVITING, OPEN MINDED ATMOSPHERE THAT PEOPLE WANT TO PARTICIPATE IN, I WOULDN'T THINK. THAT SOUND VERY AUTHORITARIAN ON HIS PART. HE WILL TWIST YOUR ARM BY THREAT OF CONSEQUENCES THROUGHOUT YOUR LIFE IF YOU DON'T COME TO COLLEGE. CHRIS: I THINK YOU NAILED IT. THE CONTEXT OF THE THINK TANKS, GATES FOUNDATION AND HIGHER LEARNING COMMISSION, WHO ARE THEY TO SAY WHAT CONSTITUTES A CONTRIBUTING MEMBER OF SOCIETY IS.

I WOULD LIKE TO KNOW WHAT HIS DEFINITION OF CONTRIBUTING MEMBER OF SOCIETY AND WARD OF THE STATE. I CAN LIST A NUMBER OF GRADUATES, DAD AND FATHER-IN-LAW, DIDN'T EVEN GRADUATE HIGH SCHOOL AND HE'S A SUCCESSFUL BUSINESSMAN. THAT'S JUST TWO AND THERE'S MANY WORKING AMONG US RIGHT NOW. CHRIS: AMEN TO THAT. THERE WAS A STATE BOARD HIGHER ED MEETING AND DR. RICHMAN WAS THERE. HE WAS THERE TO TALK ABOUT EXPANSION OF THE FARGO CAMPUS RAISE MONEY PRIVATE OR WHATNOT. HERE'S THE KEY THING I WANTED TO BRING UP. KATHY NESET IS THE FORMER CHAIR PERSON OF THE BOARD OF HIGHER ED, MONDAY OR TUESDAY THE NEW CHAIR PERSON DON WARD WILL JOIN US ON THE SHOW. THAT IS AN EMAIL KATHY SENT TO NOW CANCELER DR. HAGGARD. I WANT YOU TO KNOW I AM INTENSELY DISAPPOINTED IN THE UTTER DISRESPECT THAT MR. RICHMAN SHOWED TO THE BOARD IN MIKE NESS AND RICK HACKER. HE SPOKE TO THE BOARD IN A CONDESCENDING WAY AS IF WE DIDN'T UNDERSTAND HIS MESSAGE. WE UNDERSTOOD HIM, SEVERAL MEMBERS DIDN'T AGREE WITH HIM. . . I WANT TO GIVE YOU CONTEXT BEFORE I ASK THE QUESTION. I REACHED OUT TO PRESIDENT RICHMAN AND WANTED TO DO AN INTERVIEW ON THE SHOW AND DENIED TWICE FOR THAT. IF YOU ARE NOT GOING TO DO AN INTERVIEW, AT LEAST SEND ME A STATEMENT. REQUESTED THAT TWICE AND WOULDN'T GET A STATEMENT ABOUT WHAT KATHY SAID.

I MADE EFFORTS TO EFFORTS TO SECURE INTERVIEWS TOO, MULTIPLE EFFORTS AND WAS DENIED. IT'S FRUSTRATING IF PEOPLE THROW OUT STATEMENTS LIKE THAT THEY WON'T EITHER DEFEND THEM OR ROLL THEM OUT. I AM GOING BACK TO THE PREVIOUS STATEMENT WARD OF THE STATE. WHY WOULD HE SPEAK IN A CONDESCENDING TONE TO THE STATE BOARD OF HIGHER EDUCATION?THOSE ARE THE PEOPLE HE'S APPEALING TO TO EXPAND HIDES CAMPUS. CHRIS: I AM UPSET BY THE FACT WE ARE THE PEOPLE WHO PAY HIS SALARY AND HE WOULDN'T EVEN GRANT A STATEMENT. CAN WE DO A SPLIT SCREEN?IF YOU LET YOUR HAIR DOWN YOU COULD BE KID ROCK OF NORTH DAKOTA.

I DON'T WANT TO RUN FOR SENATE. CHRIS: STAY WITH US, A LOT OF YOU HAVE BEEN ASKING WHAT HAPPENED TO OUR POINTS OF VIEW. WE HAVE A LOT OF YOUR POINTS OF VIEW COMING UP LATER IN THE SHOW. >

IS THERE A CASE FOR FOSSIL FUEL DEVELOPMENT. WE WILL HEAR FROM JOHN ABOUT WHAT DR. RICHMAN SAID ABOUT A HIGH SCHOOL DEGREE POTENTIALLY BEING A WARD OF THE STATE. LEAVE US AN EMAIL. WE WILL BE RIGHT BACK. ¶¶CHRIS: AS YOU KNOW THERE'S BEEN A LOT OF DEBATE ABOUT FOSSIL FUELS AS OF LATE. BIG QUESTION IS THERE A MORAL CASE FOR FOSSIL FUELS?THAT'S AN EVENT COMING UP IN FARGO. COMING UP IS JASON WITH AMERICANS FOR PROSPERITY.

GLAD TO BE BACK. CHRIS: KEEP IT IN THE GROUND. IS THERE A MORAL CASE FOR FOSSIL FUELS?

SO MANY PEOPLE APPROACH FOSSIL FUEL DEVELOPMENT AS A NECESSARY EVIL OR SOMETHING WE ARE ADDICTED TO. WHEN THEY TALK ABOUT IN THOSE TERMS THEY MISS THE BIG PICTURE OF WHAT FOSSIL FUEL INDUSTRIAL DEVELOPMENT HAS DONE. YOU NEED TO LOOK AT NOT JUST WHAT THE NEGATIVES ARE BECAUSE YOU ARE MISSING THE BIG PICTURE. THINK OF THE DOCTOR PROVIDING YOU DRUGS THAT COULD POTENTIALLY SAVE YOU LIFE. LEAVE THAT PART OUT AND TALK ABOUT THE NEGATIVE, THE SIDE EFFECTS AND STOMACHACHE OR HEADACHE THAT WENT WITH IT, BUT EXTENDING YOUR QUALITY OF LIFE. THAT'S WHAT FOSSIL FUELS HAVE DONE FOR HUMAN BEINGS AS WE HARNESS THAT TECHNOLOGY AND THAT GETS LOST AND FOCUS ON JUST THE NEGATIVES OF IT ALL. CHRIS: WHAT'S YOUR TAKE WHEN YOU HEAR FOR EXAMPLE MARK ZUCKERBERG IS RECENTLY IN NORTH DAKOTA. IN HIS POST HE SAYS IT'S INTERESTINGLY THAT SCIENCE SUGGESTS THAT FOSSIL FUELS CONTRIBUTE TO CLIMATE CHANGE. IS THIS SCIENCE ACCURATE?

HE'S MISSING THE ENTIRE SIDE OF THE ARGUMENT WHERE FOSSIL FUELS HAVE CONTRIBUTED TO MAKING THE HUMAN CONDITION BETTER. CHRIS: I UNDERSTAND THAT. DO YOU UNDERSTAND WHAT HE'S SAYING?

WHETHER THEY DO OR NOT, AGAIN IT'S BESIDE THE POINT. YOU CAN HAVE EXPERTS AND SCIENTISTS THAT AGREE ON A SMALL IMPACT OR TINY INCREASE ON TEMPERATURE CHANGE. THE BROADER IMPACT IS WHAT IF WE DIDN'T USE FOSSIL FUELS? LOOK AT MINNESOTA AND OTHER STATES PUT IN PLACE A RENEWABLE ENERGY MANDATE, ALL IT DOES IS INCREASE COSTS. THEY HURT THE POOREST, THE LEAST FORTUNATE AMONG US. WHEN YOU ARE TALKING ABOUT PERCENTAGE OF INCOME THAT'S PAID TO ELECTRICITY AND FOOD AND BASIC CONSUMER GOODS AS WE INCREASE ARTIFICIALLY THOSE PRICES, THOSE PRICES GO UP MEANING THOSE PEOPLE CAN'T AFFORD IT. TECHNOLOGY, WHAT FOSSIL FUELS HAS DONE, TAKEN HUMAN CONDITION FROM SUBSISTENCE INTO SURPLUS AND ENHANCING MANY PEOPLE'S LIVES. CHRIS: I THINK MANY PEOPLE WOULD AGREE. I AM CURIOUS WHAT YOU WOULD SAY TO A NATIVE AMERICAN THAT WOULD SAY SEVEN GENERATIONS DOWN IN THE FUTURE AND IF WE DON'T CHOOSE TO STOP USING FOSSIL FUELS, IN SEVEN GENERATIONS WE DON'T KNOW WHAT THIS WORLD WILL LOOK LIKE?

GO BACK SEVEN GENERATIONS IN THE PAST AND LOOK AT BOSTON, HOUSTON AND THEIR QUALITY OF LIFE, IMPACT OF WOOD SMOKE, SAFE WATER, LOOK AT TODAY PEOPLE'S ABILITY TO ACCESS WATER ACROSS THE GLOBE, IT'S NOT BECAUSE OF TECHNOLOGY, IT'S BECAUSE OF A LACK OF TECHNOLOGY AND THE ABILITY TO USE THOSE FOSSIL FUELS AND THE TECHNOLOGY RELATED TO IT. WE NEED TO BE CAREFUL HOW WE USE IT. JUST LIKE THE DRUG ANALOGY, THERE ARE OTHER FACTORS AND THINGS WE NEED TO MITIGATE. LOOK HOW WE ARE GETTING BETTER WITH MORE ENERGY EFFICIENCY. CHRIS: LET'S TALK ABOUT YOUR EVENT COMING UP JULY 25TH AT THE HOLIDAY INN TUESDAY NIGHT.

GOING TO BE A GREAT DISCUSSION WITH SOME OF OUR NATIONAL FOLKS TALKING ABOUT THE CASE THAT. . . MAKES IN HIS BOOK TALKING ABOUT OTHER SIDE OF THE STORY. WE DON'T FOCUS ON THE NEGATIVES, BUT HAVE TO FOCUS ON THE POSITIVES. GOING TO BE A DISCUSSION WITH DINNER AND GREAT DISCUSSION WITH FOLKS. BRING YOUR IDEAS AND QUESTIONS. WE WANT TO ENCOURAGE A HEALTHY DEBATE. CHRIS: GREAT STUFF. YOU HAVE THE FACEBOOK PAGE UP THERE IF YOU WANT TO SIGN UP FOR THIS THING AND BE A PART OF IT. WE WILL BE RIGHT BACK. CHRIS: WELCOME BACK, I HAD TO SHARE THIS PICTURE WITH YOU. THIS IS

SO I JUST WANT TO THANK THOSE FOUR HEROES AND ALL THE GREAT MEN AND WOMEN THAT WENT OUT THERE ON 9-11, FIRST RESPONDERS. NOW, WHEN YOU GO OUT THERE THEY ARE RAISING MONEY FOR AN ORGANIZATION THAT'S HELPING TO RAISE MONEY FOR SMART HOMES FOR OUR MEN AND WOMEN THAT SERVE OUR GREAT NATION. IT'S A GREAT THING. WELCOME BACK TO POINT OF VIEW, THE FIRST AND ONLY INTERACTIVE TV SHOW HERE IN THE VALLEY. I DON'T HAVE A PRODUCER RIGHT NOW. WE HAVEN'T BEEN ABLE TO GET TO THE FEEDBACK WE WANT TO.
