On 06-27-17 Davenport Police took a report of Fraud. As a result of the investigation, a warrant is being requested for the arrest of the defendant, Audrey E. Slyter.

The defendant did commit Ongoing Criminal Activity. From the period of 02-14-17 through 06-23-17 the defendant did represent herself as an employee of a law firm representing the victim's grandson who was incarcerated. The defendant, along with the co-defendant's, did obtain 20 checks with a total value of \$35,875.87 which were believed to be used for the victim's grandsons attorney fees and other fees associated with his incarceration. The defendant was not a member of any law firm and none of the funds obtained from the victim were used for the victim's grandson.
