This report reflects the involvement of Lt. DeSmyter, Sgt. Veronda, Deputy Pena, and myself (Deputy Asquini) involvement in assisting the Illinois State Police, the Henry County Sheriff's Office and other Law Enforcement agencies in the apprehension of Offender/Frank Scott.

On 02/24/2019 at approximately 1937 hours, Deputy Pena and I were dispatched to assist Illinois State Police and Henry County. Dispatch advised Frank had shot a firearm at a tanker trailer and subsequently fled from an investigative stop in Henry County, IL. The fleeing vehicle (Gray 2005 Volkswagen Passat, IA Registration: HRP277) was involved in a single-vehicle crash at approximately mile marker 1 of I-80 in the westbound lanes. Deputy Pena and I arrived on scene at approximately 2000 hours. I observed the suspect vehicle crashed just northwest of the exit ramp towards RT 84 N. Officers on scene advised Frank fled to the top of this hill.

As the hill was being surrounded, a caller advised they observed a black male, possibly wearing a black jacket and jeans running westbound across I-80. Some available units began to disperse and check the area.

Deputy Pena and I began to search the surrounding area. While checking the rest area (MM1 eastbound traffic), we observed a large transport bus parked. I observed one East Moline officer and one Hampton officer engaged in what appeared to be a struggle with a single individual. It should be noted, Deputies were not in direct radio contact with either Hampton or East Moline units at this time and were unaware of the situation which was unfolding. Due to the proximity of this location to I-80 and the caller advising they had seen a male running in the general direction of the rest stop, I believed it was possible the officers had located the suspect.

Upon arrival, I observed the officers had the individual in handcuffs and he was laying on the ground. The male was wearing a black jacket, matching the description given by dispatch. The Officers requested my assistance to stay and secure the subject while they responded to the bus to speak with the driver and other occupants. I placed my right knee on the subject's lower back. After speaking with the bus driver, the other Officers advised me it wasn't the person who we were searching for. Deputy Pena and I left the scene to continue the search.

At approximately 2030 hours, another caller informed dispatch a subject had just knocked on her door (RT 84 N) and used the telephone. The caller advised the subject to be a tall, black female with dreadlocks wearing a light jacket and carrying a pale green purse. It was also reported the caller was unsure if the subject was a male or female. The caller advised the subject left the residence after placing the call, possibly heading north on RT 84 N. Units began to search this area.

At approximately 2054 hours, another caller advised they observed a subject in their backyard, S. Shore LN, Rapid City. At approximately 2059 hours, LT. Desmyter advised he saw a subject running on S. Shore LN/1ST AV, Rapid City. As this was occurring, multiple units had begun to set up a perimeter on RT 84 N. As information was disseminated to residents of the area, calls began to come in about multiple open doors and garages. Units began to search and clear these areas. Lt. DeSmyter checked the area and spoke to a resident in the area that the subject was last seen running.

At approximately 2244 hours, it was relayed to dispatch there may be a subject in the 1900 BLOCK-1ST AV, Rapid City. Lt. DeSmyter then observed the suspect running westbound from 1st Avenue through a backyard. A foot pursuit ensued heading westbound behind the residences along the river. Officers repeatedly identified themselves as the police and repeatedly told the suspect to stop, and to show his hands, The suspect continued to run and attempt to evade arrest.

At this time, I was positioned in approximately the 18600 BLOCK-RT 84 N. I was walking towards my squad car which was parked on the north side of RT 84 N. I heard shouting coming from the direction of the river. I began to

run northbound towards the residences. I made my way through the backyard of RT 84 N and met with LT. Desmyter, who advised he had been pursuing the subject this way. There were officers positioned on both the west and east side of this area, which meant the subject was likely located in the immediate vicinity. Lt. Desmyter and I observed a deck at RT 84 N with a large opening underneath it. This opening faced the river. LT. Desmyter and I began to clear the opening. In the far right (west) corner of this area, the deck began to narrow, however there was an opening large enough a person could possibly be hiding in. LT. Desmyter and I began to clear this area.

ASSIST OTHER POLICE DEPARTMENT

As I crawled closer to the opening and began to clear the inside of it, I immediately observed an individual hiding inside. I could see the person was facing away from me and on their knees. The individual appeared to be crawling away from me. I pointed my duty-issued firearm at the individual and I ordered them to stop moving and to show me their hands. The individual stopped moving and raised their hands up. I observed the subject to be a black male. The male had a green purse draped around his shoulder. LT. Desmyter moved closer to my position and advised he would take over commands.

The individual was ordered to crawl out of the opening and to lay on his stomach with his hands and feet spread. Det. Griffin and I approached the male. I grabbed the subject by his left wrist and moved it to the small of the subject's back. I did the same with his right wrist. Det. Griffin secured the subject in handcuffs without issue. Det. Griffin searched the subject and the purse. He advised there was indicia inside the purse identifying this male as Frank.

Det. Griffin, Lt. Desmyter, and I assisted in removing Frank from the area under the deck. Due to the low height and tight quarters, Frank was sat on a ladder and the ladder was pulled out by assisting Deputies. Frank was walked away from the residence and custody was transferred over to Illinois State Police.
