

# Hillcrest Cemetery a discussion of options

#### Overview

- Approximately 70 acres
- Between 16,000 18,000 burials
- Marked burials dating back to the 1870s
- Since 1884, the cemetery has been owned and operated by a not-for-profit cemetery association, Temple Cemetery Company, which is overseen by volunteer trustees

## Background on Today's Conversation

- Several months ago, Staff met with the Chair and Vice Chair of the Hillcrest Cemetery Board, at their request
- The Board members expressed their concerns that the current level of City funding, combined with their other sources of revenue, may not be enough to sustain their operations
- They requested the City consider increasing the annual contribution (request was to \$100,000) or consider taking over the ownership and maintenance of the cemetery
- Over the past several months, Staff has been evaluating options to present to Council for consideration

# Current Operation of the Cemetery

- 1 office employee on payroll (30 hours per week)
- 1 office employee by contract (20 hours per week)
- 1 maintenance employee by contract (20 hours per week)
- Contract for lawn maintenance (\$50,000 per year)

## Options for Consideration

1. Continue granting \$50,000

2. Increase grant amount

Assume ownership and management of cemetery



# If Option 3, Proposed Operation of the Cemetery

Key Expenses	
Lawn Maintenance	50,150

Utilities	7,409
Payroll Expense	4,360

Contingency	5,000
Total Expenses	110,654

- TAP pay / reclass pay for 1 employee
- Contract for lawn maintenance (\$50,000 per year)
- Contract for records processing



Note: Key revenues and expenses is highlights only and not an all inclusive list. Total revenues and expenses includes budget for all revenues and expenses.

## Things to Consider:

- Annual budget does not include unforeseen items
  - Records are incomplete and I anticipate unforeseen items coming up
- Annual budget does not include major maintenance items such as road repair, drainage work, etc.
- Will need specialty cemetery software program to manage records
- Not uncommon for cities to own and operate cemeteries
  - Killeen, Waco, San Marcos, College Station, etc.
  - Almost always found under the Parks and Recreation Department



#### Next Steps:

 If Option 3, need a few more months to complete title work, work with Hillcrest Cemetery Board, train staff, purchase software, develop policies, etc.

Anticipate a transfer could occur by April 2019, if desired
