Briles announces indefinite suspension for violation of team policy

WACO, Texas — Baylor head coach Art Briles announced Friday the indefinite suspension of defensive end Tevin Elliott from the football program for violation of learn policy.

Elliott, a sophomore from Mount Pleasant, Texas, did not participate in spring workouts that concluded earlier this month and missed Baylor's Alamo Bowl win due to a knee injury. He totaled 63 tackles over the last two seasons.

Briles will have no further comment at this time.

Dear Mr. Elliott:

In accordance with Article VI Section (F) (1) (a) of the Baylor University Student Disciplinary Procedure, <u>effective today Monday</u>, <u>May 21, 2012</u>, <u>you are immediately expelled from Baylor University</u>. This provision of the Student Disciplinary Procedure permits immediate sanctions against a student, subject to a subsequent hearing, if the student is arrested for a criminal offense constituting a felony or a Class A misdemeanor. On May 4, 2012, the Associate Dean for Student Conduct Administration received notice that on or about April 30, 2012, at Waco, Texas, you were arrested for sexual assault which is a felony of the second degree criminal offense.

As a result of this immediate expulsion, you are not permitted to be on the Baylor campus at this time. This restriction includes events on the campus or on Baylor property and participation in services provided by the University to students. The only exception to this restriction is that we are allowing you to retain access to your Baylor e-mail account service for now. If you feel you must return to campus for any reason, you must obtain permission from me or Bethany McCraw, Associate Dean for Student Conduct Administration, prior to your arrival on the campus. If you are granted permission, I will notify the Baylor Police Department that you are authorized to be on campus. A violation of this condition can result in your arrest for criminal trespassing and your permanent expulsion from Baylor University.

This letter also serves as notice to you that for disciplinary purposes you are charged with student misconduct that is in violation of Baylor University Student Disciplinary Procedure. Based upon a report by the Baylor University Police Department, you are charged with the following misconduct:

On or about April 15, 2012, you committed two acts of sexual assault against another student.

It is your responsibility to contact my office within three (3) business days to schedule a meeting with me. Therefore, I should hear from you by Thursday, May 24, 2012. Please call my office at (254) 710-1715 during office hours to schedule a specific time to meet with me. My office is located in Clifton Robinson Tower, Suite 270, at 700 South University Parks Drive. You will have the opportunity to either admit or deny the charge. If you admit the charge, I will

set the sanction(s). If you deny the charge, a hearing will be required. The hearing may be either an Administrative Hearing with a Judicial Affairs official or a Disciplinary Committee Hearing with faculty and students.

If you fail to contact my office by <u>Thursday, May 24, 2012</u>, and fail to meet with me, you waive your opportunity for a hearing. I then may find you committed the alleged misconduct and impose sanctions against you without your having a meeting with me.

In addition, please be advised that the process for appealing sanctions or decisions is set forth in Article VI Section (D) and Section (E) of the Student Disciplinary Procedure. However, when immediate sanctions have been imposed against a student pursuant to Article VI Section (F) of the Student Disciplinary Procedure, the Vice President for Student Life and the President may not consider an appeal of the sauction until the preliminary procedures set forth in Article VI, Section (A) have occurred and a decision has been rendered.
