9738 Gilded Cider Blvd, in the City of Madison, Wisconsin is a two story single
family dwelling with an attached garage. 9738 Gilded Cider Blvd, is composed of
dark grey vinyl siding. In facing the front of 9738 Gilded Cider Blvd, on the left
side of the front covered porch are the numerals "9738", black in color

which things may constitute evidence of a crime, to-wit: Attempted First Degree Intentional Homicide, committed in violation of Section(s) 940.01 (939.32) of the Wisconsin Statutes, and prays that a Search Warrant be issued to search said premises, vehicles and persons unknown within said premises for the property aforesaid. That the facts tending to establish grounds for issuing a Search Warrant are as follows:

FACTS:

Your complainant is a Special Agent with the Wisconsin Department of Justice, Division of Criminal Investigations and has so been employed as a law enforcement officer for the last 13 years in the State of Wisconsin.

Your complainant received information from the City of Middleton Police Department and documented under case number 18-7916, in the regular course of that agency's official government business, that on September 19, 2018 at approximately 10:25am the Middleton Police Department received 911 calls regarding an active shooter at WTS Paradigm LLC, located at 1850 Deming Way Ste 120, in the City of Middleton, County of Dane, Wisconsin.

Prior to officer's arrival, witnesses identified a single male Asian individual armed with a firearm, who they stated was Anthony Tong. Detective David Schultz later made contact with witness R.D. who indicated she was able to identify Tong as a co-worker who was shooting a handgun. She could observe him shooting in the office and feared for her safety. Special Agent Kenneth Peters later interviewed a victim E.W., who sustained ten gunshot wounds from today's incident at WTS Paradigm LLC. Several shots were fired within the business and multiple people were injured. Officers from Middleton Police Department and Dane County Sheriff's Department arrived on scene at approximately
