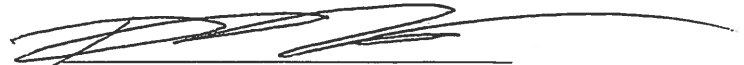

Randall S. Johnson, in the County of Rutland, at Rutland City on or about August 27, 2017, was a person who unlawfully killed another human being, to wit: by compressing Trina Fitzgerald's neck, while acting with wanton disregard of the likelihood that his behavior may naturally cause her death or great bodily harm, in violation of 13 V.S.A. 2301.

Penalty: Imprisoned for life and for a presumptive minimum term of 20 years.

Now comes Detective Sergeant Samson Delpha, affiant, being duly sworn and on oath, deposes and says he has probable cause to believe **Randal S. Johnson, dob(7-22-59)** has committed the offense of **2nd Degree Murder, a violation of TITLE 13 VSA 2301.**

I am employed by the City of Rutland as a full time Police Officer. I am certified by the Vt Criminal Justice Training Council as a full time Police Officer and have been so certified since May 22, 1998. I am currently assigned to the Bureau of Criminal Investigations as a Detective Sergeant.

On Sunday 8-27-17 at approximately 2150 hours the Rutland City Police Department responded to a domestic assault incident at 45 Madison Street apartment 2C. The police dispatch received a phone complaint from a male identified as Randal Johnson dob(7-22-59), and a female identified as Trina Fitzgerald dob(5-8-59). Johnson called 911 first who then transferred the call to our dispatch to say Fitzgerald was threatening to throw something at him and wanting him to leave. Fitzgerald called the RCPD dispatch directly reporting Johnson was putting his hands over her mouth trying to stop her from breathing and she wanted him to leave. The case number initiated for this case is 17RL08868.

Field Training Officer Billings, Corporal Alger and Officer Cleveland were assigned to respond. The following is the narrative from Officer Billings Report:

{{On 08/27/2017 at approximately 2150 hrs. Cpl. Alger and I were dispatched to 45 Madison Street; Apt 2c for a report of a domestic situation. It was reported that Trina Fitzgerald (05/08/1959) had thrown items at Randal Johnson (07/22/1959). It was also reported that Johnson put his hands over Fitzgerald's mouth and nose.

Upon arrival I did not hear any arguing or noise coming from inside of the apartment. I knocked on the door and Johnson answered and invited Cpl. Alger and I in. Fitzgerald appeared to be in distress. She was crying and coughing very loud. Her face was a bright red. Fitzgerald was sitting in a chair in the living room with a table in front of her. Johnson claimed that Fitzgerald had not been taking her medication, Fitzgerald claimed that he was lying. Cpl. Alger went into the hallway and spoke with Johnson as I stayed with Fitzgerald and spoke with her.

Fitzgerald refused medical attention right away. Fitzgerald claimed that her and Johnson had began fighting over the fact that she was talking and Johnson wanted her to be quiet. Fitzgerald stated that as the arguing escalated Johnson got up off the bed he was lying on and went behind her and put his hand over her nose and mouth for approximately two minutes before letting go. Fitzgerald also claimed that at some point during the argument, that Johnson had picked up her box of medication and threw it on the table in front of her spilling her milk.

While I was speaking to Fitzgerald her coughing progressively got worse and worse. She began to have trouble composing a sentence without having to stop and cough. I asked multiple times while speaking with her if she needed an ambulance, in which she replied no and she would be all right as long as Johnson left. I observed that there was no sign of a struggle taking place inside of the residents.

Ofc. Cleveland stayed and spoke with Fitzgerald as I went out and spoke with Johnson in the hallway. Johnson explained that Fitzgerald was not taking some of the medication prescribed to her and she refused to have certain testing done. Johnson stated that while he was sleeping Fitzgerald became agitated and started yelling at him and throwing items at him. He denied ever putting his hands on Fitzgerald. Johnson agreed to leave the residence as he had done in the past when the two argued.

When Johnson was packing his items he seemed worried that Fitzgerald needed an ambulance because she may have been having a panic attack. Johnson left the residence with Cpl. Alger.

Fitzgerald was coughing more at this point and I again asked her if she needed an ambulance. She was adamant that she did not and would be fine when Johnson left. When I left the apartment Fitzgerald was sitting in her chair in the living room coughing.

Cpl. Alger and I watched Johnson walk east up Madison Street. He stated he was going to stay with a friend.}}

The officers on scene did not see any visible injuries and decided Johnson leaving was the appropriate resolution and completed the call. Dispatch radio log of this case shows the officers complete at 2209 hours.

At 2213 hours, Vermont 911 received a phone call from Trina Fitzgerald reporting she was having a hard time breathing. Regional Ambulance Service was called at 2216 hours, and arrived on scene at 2219 hours. On arrival, Regional Ambulance Service employees found the apartment door locked and had to retrieve a pry bar to gain entry. Upon entry, they found Fitzgerald unresponsive and pulseless seated upright in a rocking chair in the living room. Attempts to revive Fitzgerald were unsuccessful and she was later pronounced dead at 2248 hours.

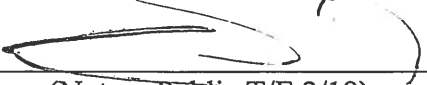
At 2248 hours, RCPD dispatch received a phone call from RAS advising of the death of Fitzgerald. Dispatch sent officers to respond and also notified Detective Corporal Gorruso to respond as well.

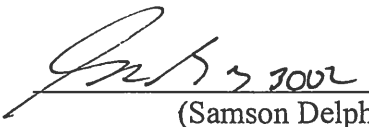
Detective Corporal Gorruso was the on call detective for the Bureau of Criminal Investigations. Gorruso took over the investigation of the death of Fitzgerald. The assistant medical examiner Gena Wener was notified and responded as well to assist the investigation of Fitzgerald's death.

Gorruso and Wener were advised of the previous call for service that the RCPD had responded to at this location. Gorruso and Wener examined the body of Fitzgerald, the apartment, and after getting some medical history information for Fitzgerald, notified the on call deputy states attorney to advise her of this

case. The information about this case was discussed and after consulting with the States Attorney Rose Kennedy, it was determined that Fitzgerald would be sent for an autopsy.

On Monday 8-28-17, Deputy Chief Medical Examiner for the State of Vermont, Dr. Elizabeth Bundock conducted an autopsy on Fitzgerald and provided Detectives with her preliminary findings. According to Dr. Bundock, Trina Fitzgerald died at the hands of another. Dr. Bundock stated she believes Fitzgerald died as a result of a Homicide based on the following:

- A. A faint contusion on the left side of Fitzgerald's neck
- B. Hemorrhage on the center of Fitzgerald's upper lip (inner surface)
- C. Petechiae and Hemorrhaging was located in the eyes and in soft tissues above Fitzgerald's collar bones
- D. Extensive hemorrhaging in and around Fitzgerald's larynx
- E. A contusion across Fitzgerald's upper back and left shoulder bone

Dr. Bundock also concluded that force was applied to Fitzgerald's neck which may have caused swelling minutes up to an hour before Fitzgerald's death.

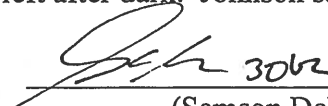
With this information, the Rutland City Police Department then considered this case to be a Homicide. The family of Fitzgerald had been contacted and interviews were set up with them. A search warrant had been applied for by Detective Corporal Dickerson for the apartment. And attempts were made to find Randal Johnson for an interview.

Randal Johnson had been located at the Comfort Inn. Johnson had checked into a room earlier in the day on 8-28-17. RCPD Commander David Lachance and I travelled to the Comfort Inn and attempted to locate Johnson for an interview. We were told by hotel staff that Johnson was in room #346. We went to room #346 and knocked on the door and were greeted by Johnson. We identified ourselves and asked Jonson if we could come into the room and talk to him, Johnson agreed and allowed us into the room. In an interview with Johnson, Johnson was asked about the incident in which the police responded to his call for service the night before with Fitzgerald. Johnson denied ever putting his hands on Fitzgerald, said he has never put his hands on a woman, and said Fitzgerald was off her medications. Johnson explained this is a normal pattern of behavior for him when he and Fitzgerald have an argument and she wants him to leave. He explained that he will normally leave the apartment anywhere from hours, to days to weeks when they argue and then he goes back and things continue between them. Johnson said he has been seeing Fitzgerald, and living with her off and on for 11 ½ to 12 years now. Johnson said when he left with the officer, he did not go back to the apartment, said he did not have a key to the apartment, and did not contact Fitzgerald or hear from her, although he was ignoring his phone. I had attempted to call Johnson myself and sent a text to his phone asking him to call me when first attempting to locate him. Johnson said he slept outside near the Rutland Free Library last night as he did not have money for a room until this morning when he could get to his bank. Johnson explained that some of Fitzgerald's family had been visiting her and had left after dark. Johnson said he fell asleep

on the air mattress in the living room and woke up to Fitzgerald yelling at him to get out, and was threatening to throw something at him as she was yelling at him. Johnson said he felt he needed to call the police as Fitzgerald was saying she was going to call the police. Johnson said Fitzgerald has mental health issues, will lie about him, and has lied about him during previous incidents involving police. Johnson said Fitzgerald sleeps in a rocking chair in the living room due to her medical issues. Johnson said he would hug Fitzgerald usually everyday and described hugging her while she was still seated in the rocking chair as from behind her, and his face to the back of her head.

During the interview with Johnson, it was apparent that he did not know Fitzgerald had died. When Commander Lachance told Johnson that Fitzgerald had died, he did not have any tears, but did seem to be in some shock.

I observed the room to be clean and orderly. Johnson did not have any visible injuries to his face or arms to indicate he was in an altercation. Johnson had on clothes that appeared clean and he had a large duffle bag on one of the two beds in the room.

We concluded the interview and confirmed phone numbers for Johnson in case we had some follow up questions for him. Commander Lachance provided Johnson with a business card and asked Johnson to call him with any questions.

RCPD Detectives learned the following information over the course of this investigation so far.

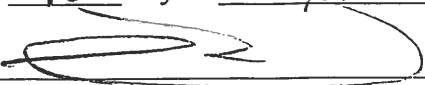
In an interview with Tammy Fitzgerald dob(12-20-80), daughter of Trina Fitzgerald, I learned that Johnson and Fitzgerald would fight and argue all the time, mostly verbal as Tammy never saw anything physical between them herself. Tammy said her mother would tell her when they were fighting and at one time said that Johnson had put his hands over her mouth during an argument. Tammy said her mother told her that Johnson would threaten to put his hands over her mouth other times they argued but only was told by her mother that he actually did it one time. Tammy said her mother described Johnson standing behind her and him putting his hand over her mouth from behind. Tammy described this happened a while ago.

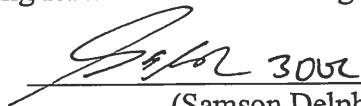
Tammy said she had to call police about 1 ½ months ago when Johnson was threatening to hit her mother over the head with a flashlight. Tammy said she did not hear this threat, but her mother called her on the phone to tell her what was going on so Tammy travelled to their apartment and because Johnson was still there when she arrived, Tammy called the police.

Tammy said her mother told her that Johnson does not like it when her mother tries to help out the children. Tammy said this has been a source of arguments in the past. Tammy said on the night of 8-27-17, she was visiting her mother along with Tammy's fiancé Tim, along with 3 of her minor children. Tammy was babysitting a 6 month old baby who was with them as well. Tammy said they were there until approximately 2055 or 2105 hours as they had been waiting for her other minor daughter to be

done at her place of employment. Tammy said when they left the apartment, only her mother and Johnson were inside. Tammy was aware of Johnson buying new phones for himself and her mother. Tammy said when she left the apartment, she used her phone to text a message to her mother saying if her mother did not want her older phone, that Tammy would take it. Tammy said her mother text her back to come up and get the phone. Tammy said she walked back upstairs and her mother met her at the entrance and handed her the phone. Tammy said Johnson was in the living room and she does not know if he saw her mother give her the phone. Tammy said she knew her mother had taken Johnson's key to the apartment as she wanted to have control over his access.

Tammy said her mother told her Johnson was taking medication for depression. This conversation came up because Johnson would tell her mother to take her nut pills, and her mother told Tammy that he did not want anyone to know he was taking these.

Tammy told me she has spoken by phone with Johnson with the last time on 9-3-17 at 2114 hours.

A check of CAD revealed numerous involvements with Johnson and Fitzgerald, and more involvements with Johnson and other subjects. One incident in 2009 under case number 09RL01829 has Johnson listed with first name spelled Randall. The complainant in this case Kimberly Durant dob(12-5-67) called the police to have Johnson removed from her apartment. In the narrative of the officers report, Durant reported that Johnson had struck her in the face in the past.

I called the phone number listed for Durant who was now showing as living in Derby Vt. I spoke with Durant who told me during the time frame in 2009 when she lived in Rutland, Johnson who she calls Randy, wanted them to be more than friends, and at one time had tried to force her to have sex. Durant recalled one time that Johnson told her to give him a blow job, she told him no and he slapped her in the face for saying no. Durant told me that Johnson had slapped her in the face one other time in the three weeks that she was around him but she did not remember what caused him to slap her. Durant told me she felt Johnson was possessive and lazy as he wanted her to take care of him as she was trying to work part time and was getting state benefits. Durant said Johnson told her to give him half of her food stamps.

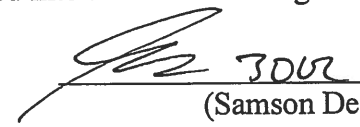
Detective Corporal Gorruso interviewed Crystal Braley who is another daughter of Trina Fitzgerald. Crystal told Gorruso that she did not regularly visit her mother because of Johnson. Crystal felt Johnson was possessive and a lazy bum describing him to sleep all day and not attempt to get a job or do anything. Crystal told Gorruso that Johnson would get angry at her mother if she did anything for her kids. Crystal described to Gorruso that she has seen Johnson grab her mother by the arms and push her mother back into a chair, and also has seen him grab her mother by the shoulders and push her back.

Johnson has an ex wife named Helen Jennings dob(12-1-63). Jennings is in CAD with domestic violence involvements that included their son Michael Johnson. In an interview with Jennings, she told me when she was pregnant for their daughter Jessica, sometime in 1989, Johnson had shoved her during an argument they were having. Jennings said she was shoved into a crib that belonged to their first child

Michael. Jennings said as a result of this shove, her water broke and she ended up having Jessica 6 weeks premature. Jennings told me Johnson was on medication to keep him calm and for depression. Jennings said when Johnson was off of his medication he was a real jerk. Jennings said she has seen Johnson hit their son Michael upside the head when he was upset with him. Jennings had filed for a restraining order on behalf of the children before. Jennings said she may have also filed a restraining order against Johnson herself at one time.

A check of CAD involvements confirmed a recent call for service where Fitzgerald reported Johnson covering her mouth with his hand. On June 5th 2015, RCPD responded to their apartment for this complaint. 15RL05233. Fitzgerald told police that Johnson put his hand over her mouth to prevent her from talking. When Fitzgerald was on the phone with police, Johnson attempted to take the phone away from her.

On July 2nd 2017, RCPD responded for the complaint previously mentioned by Tammy regarding Johnson threatening to hit Fitzgerald in the head with a flashlight. 17RL06398.

The audio recording for the 911 calls, and the calls to the RCPD dispatch on 8-27-17 were obtained and it is clear that Fitzgerald's condition was worsening in the short time frame from when she called police, their response, and the subsequent call to 911 for help with her breathing.

Johnson was alone with Fitzgerald after Tammy and the others left around 9pm, and Johnson was alone with Fitzgerald when the officers arrived. The 1st call to the RCPD was approximately 2150 hours. Officers Cleared at 2209, and just 4 minutes later, at 2213 Fitzgerald is calling 911 for help.

If the assault occurred around the time frame police were called at 2150, and Fitzgerald was pronounced dead at 2248. The injury happened when Johnson was the only one in the room with Fitzgerald and is consistent with Fitzgerald reporting Johnson covering her mouth.

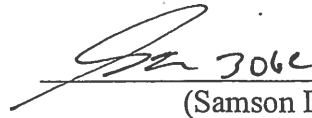
With the above information, I applied for and was granted a search warrant to record conversations with Randal S. Johnson. The search warrant application was reviewed and granted by the Honorable Judge Corsones on 9-12-17 at 824am.

On 9-12-17 at approximately 1518 hours, Tammy called Johnson. During the phone conversation, Johnson told Tammy that he has put his hands over Fitzgerald's mouth two times with the last time being about a year ago. Johnson told Tammy he did threaten to hit Fitzgerald with the flashlight in July because she kept after him. Johnson said he does not remember if he took his medication the night Fitzgerald died. Johnson said he was sorry for hurting Fitzgerald's feelings. Johnson also said he was sorry for hurting Fitzgerald or her feelings. During this phone call, Johnson denied covering Fitzgerald's mouth the night she died.

Johnson also said Fitzgerald did not do anything wrong, said that her mood just changed. Johnson said he did not remember what they talked about that led up to Fitzgerald telling him to get out.

Johnson told Tammy that Fitzgerald said it scared her when he covered her mouth. Johnson said he covered Fitzgerald's mouth to get her to stop. Johnson also said he knew the hand over mouth was wrong.

On 9-13-17 at approximately 1340 hours, Tammy called Johnson. During this conversation, Johnson did not reveal any new details about the night Fitzgerald died.

On 9-18-17, I received a final report of autopsy regarding Fitzgerald. The final report Diagnosis is listed as {{ I. Neck Compression.

- A. Contusion, left side of neck.
- B. Soft tissue hemorrhages consistent with anterior-posterior neck compression.
 - 1. Sternocleidomastoid muscles, bilateral.
 - 2. Pharynx and posterior larynx.
- C. Petechiae above level of clavicles, florid.
- II. Contusion of Upper Back.
- III. Contusions, Anterior Right Upper Arm and Lateral Left Calf.
- IV. Obesity (Body Mass Index 45.8).
- V. Arteriosclerotic Cardiovascular Disease.
 - A. Atherosclerosis of coronary artery, slight.
 - B. Arteriosclerosis.
 - C. Myocardial interstitial fibrosis.
- VI. Steatosis and Cirrhosis of Liver, Etiology Undetermined.
- VII. Diverticulosis.
- VIII. Chronic Bronchial Asthma.
- IX. Diabetes Mellitus, Type 2 (by report).}}

The Cause of Death is listed on the final report as Neck Compression. In the narrative section of the final report of autopsy under the Injuries section, Dr. Bundock documents a "2 x 2" purple contusion of the lateral right neck where it transitions to the top of the shoulder."

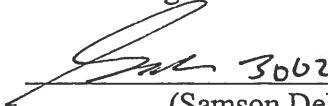
On 9-18-17, I travelled to the Comfort Inn to locate Johnson. Johnson was no longer checked in but the desk clerk said Johnson was due to have a room tonight as he just spoke with Johnson about 10 minutes ago.

I located Johnson at the library on Center Street. I told Johnson that I had some updated information and had some follow up questions for him and asked him if he would be willing to come to the PD to answer some follow up questions. Johnson said he would. Johnson walked with me to my car, he was not placed in handcuffs and sat in the front passenger seat of my unmarked assigned BCI vehicle.

Johnson walked with me upstairs to an unsecured BCI interview room. I told Johnson because he was here at the PD and I had some follow up questions for him, that I was going to read him his Miranda warnings. I then read Johnson his Miranda warnings using the Miranda warnings sheet. Johnson answered yes after each warning when I asked if he understood each. I asked Johnson to read the waiver portion out loud to me so I knew he understood it. Johnson said he was not going to read the waiver. Johnson said he will take a lawyer, a public defender.

I left the interview room, and came back a short time later and placed Johnson into handcuffs. Johnson was going to be brought downstairs to a secure holding cell and before leaving the BCI area, Johnson said maybe he will answer some questions then said he was willing to answer questions. I told him that he requested a lawyer and that we were going downstairs to the cell.

I placed Johnson in a secure holding cell. Johnson asked me if we were going to do the questions in this cell and said he would answer questions. I reminded him that he said he wanted a lawyer and Johnson said something like he would waive it.

I brought Johnson to an interview room in the secured area. I told Johnson he was under arrest and because I wanted to ask follow up questions, I would have to read him his rights. I told him because he said he wanted a lawyer I could call one, could call the on call or a lawyer if he had one in mind. Johnson said he wanted to have a lawyer with him here at the PD to be questioned. Johnson said he wanted me to call the on call lawyer.

I attempted to contact the on call public defender, Brian Marsicovetere. I spoke with a female who said he could be reached by his cell number. I called the cell number and had to leave a message asking for a call back. I did not hear back from Marsicovetere.

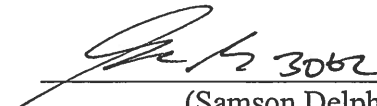
I then called the back up on call public defender, Steve Zwicky. I left a message asking for a call back and a while later, spoke with Steve Zwicky on the phone. Zwicky said he would not be coming in to the PD and asked to speak with Johnson. Johnson spoke with Zwicky by phone in the DUI attorney phone room. After they were given a chance to talk, I again spoke by phone with Zwicky who told me that Johnson would not be answering any questions. I then confirmed with Johnson that he spoke with Zwicky and confirmed that he was not going to answer any questions.

Based on our investigation, it is clear that Johnson was alone in the apartment with Fitzgerald after her family members left. Fitzgerald called the police to report Johnson put his hands over her mouth and kept her from breathing. This type of activity has happened in the past, as heard from Johnson himself during the phone call with Tammy. This contradicts what Johnson told us during our first interview with him when he said he has never put his hands on a woman. Johnson also confirmed a previous report by Fitzgerald to her daughter Tammy who called the police about the threats to hit Fitzgerald in the head with a flashlight. Johnson told the responding police officers on 8-27-17 that he was with Fitzgerald

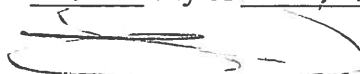

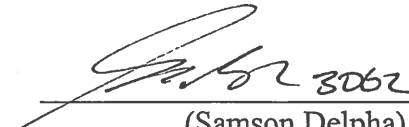
and that he did not touch her. Johnson left with the police officers and did not have a key to get back into the apartment. The ambulance personnel had to use a pry bar to gain entry where they found Fitzgerald in the chair alone. The final autopsy reports toxicology section listed several items in Fitzgerald's blood that show she had taken her prescribed medication which also contradicts Johnson's claim that Fitzgerald was off her meds.

Based on the above information, I have probable cause to believe Randal S. Johnson has committed the offense of 2nd Degree Murder by causing injuries to Trina Fitzgerald's neck that caused her death.

Now comes Detective Sergeant Samson Delpha, affiant, being duly sworn and on oath, deposes and says he has probable cause to believe **Randal S. Johnson, dob(7-22-59)** has committed the offense of 2nd Degree Murder, a violation of TITLE 13 VSA 2301.

On 9-18-17 at 2207 hours, I called and spoke by phone with Jessica Shore dob(3-18-89). Shore is currently living in the state of Washington and is the daughter of Johnson. I asked Shore if she spoke with Johnson on the day we first interviewed him regarding Fitzgerald. Shore told me Johnson called her after we left the hotel room and he told her that Fitzgerald had passed away. Johnson also told Shore that he and Fitzgerald had been in an argument, told Shore that Fitzgerald told the police that he put his hand over Fitzgerald's mouth and told Shore that he was asked to leave by the police so he stayed overnight outside near a church as he did not have a place to stay that night.

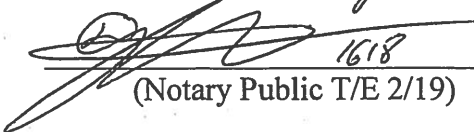
I asked Shore if she ever saw Johnson being violent towards anyone in the past or hitting and or slapping them and she said no. I asked Shore if Johnson was ever violent or hit her or slapped her and she told me when she was young and Johnson was trying to make her mind, he would cuff her upside the head.

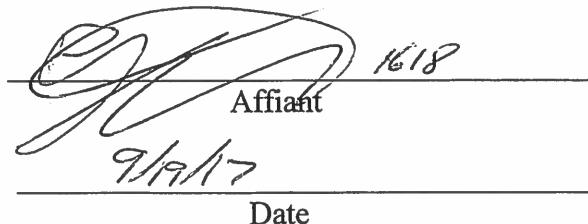
NOW COMES, **Detective Daniel Meytin** affiant, being duly sworn on oath, deposes and says:

1. I am a full-time certified law enforcement officer in the state of Vermont. I am currently employed by the Rutland City Police Department (RPD) as a Detective with the Bureau of Criminal Investigations (BCI), assigned to the Rutland Unit for Special Investigations at the Child First Advocacy Center (CFAC).
2. On August 28, 2017, I spoke to Jarren J. Fitzgerald (DOB: 09/22/1994) in the second floor hallway of 45 Madison Street, Rutland City, VT. Jarren was the son of Trina L. Fitzgerald (05/08/1959). Jarren advised the following: Jarren resided at 45 Madison Street; Apt 2C with Trina and Trina's boyfriend Randal (Randal S. Johnson (07/22/1959)). He had been living there for approximately six months. On 08/27/2017, Jarren was going to spend the night with his girlfriend. He stopped by at the 45 Madison Street apartment to collect some clothing at approximately 2100-2115 hours. Trina, Randal, Jarren's sister Tammy (Tammy L. Fitzgerald (DOB: 12/20/1980)), and Tammy's boyfriend Tim (Timothy D. Farr (DOB: 11/22/1978)) were inside with some of Tammy's children. Everyone appeared to be in a good mood. Jarren only stayed for a few minutes to collect some clothing before leaving for his girlfriend's residence. The next morning, Jarren was contacted by the mother of his child who advised him that she had tried to drop some things off at his apartment and no one answered the door. Jarren tried to contact Trina but could not reach her.
3. On 09/07/2017, I met with Jarren again at the RPD station. I went over the events of 08/27/2017 as Jarren had previously told them to me and he confirmed the information was still correct. Jarren advised that the only people who had keys to 45 Madison Street; Apt 2C were himself, Trina, and his brother Robert (Robert E. Braley (DOB: 12/27/1978)). Jarren did not remember which of Tammy's children were at the apartment when he stopped by.
