The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant on Tuesday August 5TH 2014, at approximately 11:31, at 7712 BASS RIDGE TR did the following violation of law:

On Tuesday, August 05, 2014, Uniform Patrol Deputies responded to 7712 Bass Ridge Trail in reference to a stabbing. Deputies arrived on scene and found M.R. (6 years old) lying on the bathroom floor with stab wounds. M.R. was transported to TMH where he was later pronounced deceased. Deputies spoke with M.R.s brother A.R. (8 years old) who told them that he and M.R. were playing video games at the house and grandma, later identified as Martha White, told the boys she had a surprise for them.

According to A.R. White took M.R. into the bathroom and shut the door. A.R. advised moments later he overheard M.R. crying and saying "I don't want to die, please don't kill me". A.R. called his father and went and hid. A.R. would later tell detectives in interviews that he tried to open the bathroom door where White and M.R. were, but it was locked. A.R. also said he observed White leave the residence holding a bottle of wine and saying to him that she had a surprise for him too.

White was not at the residence when deputies arrived. According to the parents of M.R. and A.R. White was babysitting them at the residence while they were at work. White's vehicle was later discovered at the dead end of Valley Creek Drive, approximately .5 miles away from the residence. Deputies later located White at a small park off of Valley Creek Drive. Deputies observed White's clothing was covered with blood and she was in possession of a wine bottle and zanax. White uttered spontaneously in the presence of deputies that she had been tortured for years by Spring (mother of M.R. and A.R.) and she was fed up. White was asked about the blood on her person to make sure she was alright and she responded that it wasn't her blood and that it belonged to A.R. White was taken into custody and due to her state she was transported to CRMC.
