The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant on , at approximately , at did the following violation of law:

On 29 January 2017 at approximately 0700 hours, the deceased body of Tiffany Nance was located in the Ochlockonee River Wildlife Management Area approximately 1 ½ miles from the Highway 90 West entrance. The area is heavily wooded and secluded with no housing developments in close proximity.

Tiffany's body was found positioned on her back and facing south – southwest. Her left arm was above her head with the left hand facing in an easterly direction, as if being dragged by her arm. Tiffany's right arm was alongside her body with her right hand under her outer thigh area. A pair of Wellflower, size 5 blue jeans was located around Tiffany's right leg. A leather belt was unbuckled and the jeans were unbuttoned, unzipped, and completely removed from the left leg. Tiffany was nude from the waist down and no panties were located on scene. There were marks on her right thigh and right knee consistent with being dragged. Her right black and white shoe was located on her right foot. A shoe matching the right shoe was located on the two-rut road leading to the scene.

Tiffany had several scrapes and marks on her chest, right thigh, and right knee consistent with being dragged. Blood around her nose and mouth was consistent with aspiration of blood.

Tiffany was wearing a collarless red shirt. The shirt was found pushed up just over the left hip and above her abdomen. The front of the shirt was dirty and had suspected blood stains on it. The blood and dirt marks were primarily on the right side of the shirt. The back of the shirt had suspected blood and what appeared to be three cuts in the fabric. The left sleeve was pushed up around her bicep area and the right sleeve was at length around her forearm. Tiffany's bra was located in the correct position on her body, covering both breasts. The strap on the left side was severed in the back, in the area of the puncture wounds. There were small sticks, dirt, and vegetation inside her bra, which is consistent with being dragged face down.

A puncture wound was located on Tiffany's upper right chest. The on-scene evaluation of the wound indicated a puncture, but at the time, we were unable to determine if the wound was from a sharp implement, a weapon, sticks, or vegetation.

During the examination of the body, Sgt. Pat McLeod with the Leon County Sheriff's Office Crime Scene Unit rolled the body on the right side, pulled up the red shirt, and exposed the three stab wounds located on her back. A stab wound was located on her upper back, left side, in the area around her scapula, measuring approximately 1" long and ½" wide. The next wound was located midway down her back on the left side, measuring approximately 1" long and ½" wide. The third stab wound was located left of center and midway down her back, measuring approximately 1" long and ½" wide.

The sexual assault kit, buccal swabs, touch DNA swabs, nail scrapings, nail clippings, and post mortem thumbprints were collected from the decedent. Fly eggs were visible in the mouth, but not collected for evidence.

During the autopsy, the jeans were visually examined prior to securing them in a bag. There was no apparent damage to the button, button hole or zipper. Tiffany's red shirt was visually examined. There were three holes on the backside of the shirt in the areas and direction of the wounds on her back.

A stab wound was located on her upper back, left side, on her scapula. Dr. Flannagan with the Leon County Medical Examiner's Office determined the wound to be approximately 1" long and 5 ½" deep. The x-ray showed the sharp implement penetrating the left scapula and entering the left lung. The second wound measured approximately 1" long and ½" wide and 5 ½" deep. The sharp object sliced through rib #8 and

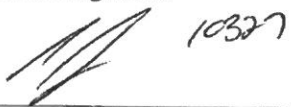
