RETURNS OF THE RANDOLPH COUNTY OCTOBER 2017 GRAND JURY

Bond Return for the indictments returned by the October 2017 term of the Randolph County Grand Jury will be on **November 6, 2017, at 9:00 a.m.**, at which time bond will be set and trial dates will be determined. I ask that you please make special note of the date and time of bond return to help publicize and, thus, notify the Defendants of that date.
