4. The material facts constituting probable cause that the search should be made are:  
JOY LYNNE SCHULTZ is married to GEORGE HAROLD SCHULTZ and share a marital home at 9006 US Hwy 340 Apt. B, Shenandoah, VA.

On September 9, 2014 Joy Lynne Schultz was reported missing by a co-worker and was last seen alive by an independent witness on September 6, 2014 at 1:00 p.m. residence 9006 US Hwy 340 Apt. B Shenandoah, VA, while she was sitting on a couch.  
GEORGE HAROLD SCHULTZ and GEORGE ZACHARY SCHUPPAN both admitted to disposing of JOY LYNNE SCHULTZ'S body by wrapping it in bags.  
On 10/22/2014 GEORGE HAROLD SCHULTZ led this investigator to a wooded area at the end of Baldor Rd. in the County of Rockingham where human remains were then located.

GEORGE HAROLD SCHULTZ stated that JOY LYNNE SCHULTZ provided for him financially by direct depositing from wages earned at SYSCO FOODS INC. into this account while she maintained other accounts he did not have access to.  
Investigation has revealed that JOY LYNNE SCHULTZ changed her life insurance policy through her employer, SYSCO FOODS INC., replacing GEORGE HAROLD SCHULTZ as the primary beneficiary with her brother LARRY CRAWFORD on September 5, 2014.

Investigation has further revealed that JOY LYNNE SCHULTZ used a work computer at SYSCO FOODS INC. to conduct personal business while at work to assist GEORGE HAROLD SCHULTZ with getting disability benefits.  
On November 15, 2014 GEORGE ZACHARY SCHUPPAN admitted to another inmate, CHADWICK WOODWARD, that their motive was a \$200,000 life insurance policy that his father, GEORGE HAROLD SCHULTZ, would split with him.
