**INDICTMENT**

In the Name and by the Authority of the State of Florida

**Count I**

First Degree Felony Murder  
782.04(1)(a)2, Florida Statutes

The Grand Jurors of the State of Florida, impaneled and sworn to inquire and true presentment make in and for the body of the County of Bay, upon their oath do present that **JOHN BRADLEY DAVIDSON** on or about the 17<sup>th</sup> day of January, 2017, in Bay County, Florida, did unlawfully while engaging in the perpetration of any act as described in s. 782.04(1)(a)2 to effect the death of a human being, Alisa Kinsaul, or while engaged in the perpetration of or in an attempt to perpetrate the felony of Burglary, did unlawfully kill Alisa Kinsaul by stabbing her with a knife, in violation of Section 782.04(1)(a)2, Florida Statutes, in such cases made and provided against the peace and dignity of the State of Florida.

**Count II**

Burglary of Dwelling  
Section 810.02, Florida Statutes

The Grand Jurors of the State of Florida, impaneled and sworn to inquire and true presentment make in and for the body of the County of Bay, upon their oath do present that **JOHN BRADLEY DAVIDSON** on or about the 17<sup>th</sup> day of January, 2017, in Bay County, Florida, did unlawfully enter or remain in a structure, the dwelling of Alisa Kinsaul, with the intent to commit an offense therein, in violation of Section 810.02, Florida Statutes, in such cases made and provided against the peace and dignity of the State of Florida.




