[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

CAD INCIDENT DISPOSITION CODE: [57-0] [A] [3] [OI]

On 6/5/2016 at approximately 1822 hours at 41 Fort Pickens Rd in Escambia County Florida Markus Bishop did commit the offense of Possession of Marijuana over 20 grams a follows.

On 6/5/2016 while on patrol in the area of the Casino Beach parking lot, I was waved down by a citizen who stated there was a white male smoking marijuana in public at the Casino Beach Bar and Grill, located at 41 Fort Pickens Rd. I was advised the male was sitting near the outside stage of the Casino Beach Bar and Grill.

Deputy Stevens #321, Deputy Meeks #303 and I went to the Casino Beach Bar and Grill and approached the outside stage through the bar. After exiting the bar and getting close to the stage Deputy Stevens told me he could smell the odor of marijuana. As we got closer to the stage I observed a white male, later identified as S/Markus Bishop, sitting on a lounge chair. S/Bishop was observed holding a baggy with what appeared to be marijuana in his hand. S/Bishop placed the baggy inside of a green bag. As I got closer to S/Bishop, I observed several other bags of marijuana in the green bag which was open and clearly visible. As S/Bishop made eye contact with us he attempted to grab the green bag with the marijuana inside it. At this point I was close enough to S/Bishop I was able to take hold of his arms and place him in handcuffs.

Located inside the green bag were three Ziploc bags of marijuana, which contained a quantity over 20 grams. In addition, there was a syringe located inside the bag with and unknown residue, which will be submitted to the lab.

S/Bishop was arrested and charged with Possession of Marijuana over 20 grams. S/Bishop was transported to
