CONDUCTING THIS INTERVIEW IS SGT. HIGGINS WITH THE BAY COUNTY SHERIFF'S OFFICE. IN REFERENCE TO CASE NUMBER 2016-092416. TODAY'S DATE IS DECEMBER 5TH OF 2016. TIME'S 10:59AM. THIS INTERVIEW IS BEING CONDUCTED AT THE BAY COUNTY JAIL. INVESTIGATOR CHANCE IS ALSO PRESENT IN THIS INTERVIEW.

Q. Ma'am can you raise your right hand? You swear to tell the truth, the whole truth and nothing but the truth, so help you God?

A. Yes sir.

Q. All right you can put your hand down. All right state your name please?

A. Tiffany Powell.

Q. And your date of birth, ma'am?

A. 9-27-88.

Q. Okay and you are housed at the Bay County Jail, is that correct?

A. Yes.

Q. Okay. Um you were in a cell with Egypt Robinson, is that correct?

A. Yes sir.

Q. Okay. You um vented to one of the C.O.'s (Correction Officer) here and explained some things that you have heard from Egypt?

A. Yes sir.

Q. Okay um...and you did that so you could get a way from her?

A. Ah not, not this, not I didn't talk to ah Lu, Lucante about getting away from her. I was just, we were talking about Egypt Robinson. Is because of the fact that her name came up and I was telling her how I thought it was wrong what she did. And she agreed. It's kind of like ah conversation between the two of us and she just wanted to know if I'd talked to y'all about it.

Q. Okay so you're, today you want to talk to us, correct?

A. Yeah sure.

Q. Okay, what um did, has Egypt told you about her case?

A. Um she told me that she killed her son. Um she told me that she's stabbed him, um multiple times and that he didn't die from the stab wounds so he was suffering. So she drowned him and then um she told me how she...ah put him in a suitcase. She dressed him in his pajamas and put his clothes all around his body. And put him by the marsh. She didn't say she put him in the marsh. She said that, I say marsh, body of water. She said that she put him on the outline of the water. And um she said that ah she has no remorse. She doesn't, she doesn't regret it. She, she still thinks till this day that he's supposed to be dead. Um she did it because she said he was the soul of Hitler. His birthday is 4-20 and um he was an evil child, is what she said. And she said that if she didn't kill him um... he was going keep, grow up and kill all of us. So basically she like saved us by sacrificing him.

Q. Did she say who, um... what made her do this or who, did-did she say that anyone played a part in this besides her?

A. Um she seems to think that um, James, I don't remember his last name. She was in love with James. He's from Sarasota. He's married. I don't know his last name and I should. She said it all the time. But um...she said that...the way that she makes it sound is like, in her mind maybe she thought that he wanted her to do what she did. But it had to do with um, higher consciousness. Um their, their souls connected their like two in one I guess. And she's ah spiritual and he's the physical. And for her to become a higher conscious she had to sacrifice something that she loved. Well, in the Facebook messages, I think she was under the impression that he wanted her to sacrifice something. But whenever she told him that A.J. was dead, um he was like I hope you're not being serious. Like if you're being serious you're going way more then under, under the jail or to jail, or to hell or whatever he said. And um... like the next day after he died, she said that there was Facebook pictures of him and his family at the beach and stuff. And she was like what the hell, like if, that's not supposed to happen. Um...her she doesn't, she doesn't really um say who made her. She, she's thinks that, she thinks that that was just, she said, she did say she thought she could bring him back. I will say that. She said that once she killed him, because she couldn't die. Cause she tried to kill herself and she didn't die. She said, that she thought that because he was her son, she could bring him back after doing the sacrifice. But the she contradicts herself, because she says that he's supposed to be dead. He was supposed to die. So...ah...

Q. Did she say where she stabbed him?

A. She said she stabbed him in the belly.

Q. Did she say about mutilating the body or anything like that?

A. Um no, she just said ah something about ah blood ritual. Um...that basically she was in the kitchen and like how you're at church and um something takes over your body and you just kind of go with it or whatever. She said that's kind of how it happened. She just grabbed the knife. She did it to him and then um she couldn't control herself. So but no, I don't know anything about ah mutilation.

She drew a picture about like ah Libra um scale and told me that's what a blood ritual was. And she um had, it was like ah drop of blood on one side of the scale. Ah knife and then I can't really remember what the third part of that was. But she drew it and she...

Q. Does she have drawings in her, her cell?

A. She did yeah, she, she would always do it on the back of her court paperwork. So that Miss Cloud can through it away. Miss Cloud always wanted to throw away the stuff cause it creeped her out. Miss Cloud, it creeped her out so... But she did it on her back of her court paperwork. They can't touch her court paperwork. So she would do her drawings on that.

Q. Okay. And does she still have these drawings?

A. I'm not sure; she's actually in open population now.

Q. Okay.

A. She's in E-5. She's not behind the door anymore.

Q. And you're behind the door?

A. I'm behind the door, yes sir.

Q. Wow, okay.

A. Yes sir. I've been trying to figure out how that's possible. Cause I've been behind the door for ten months now and I don't think it's fair.

Q. I agree with you on...

A. (Laughter).

Q. On...this circumstance.

A. Yeah I mean, if their going to compare somebody, the need to be fair about it, you know what I mean? So...

Q. Did um...anything else that's important to this case?

A. Um...like I was telling Mr. Coram, um I feel like there's more that I should, I just, she, she told a lie. I do know that that she doesn't cry for the boy. You know what I mean, it, it's sick, it's, she's sick. She's a sick individual. She feels like she's god, she says things like she's a queen of illuminati. Um... I honestly, I don't really know what that means. I thought that um...like people say that the rappers that hold up the triangle and stuff like that. She thinks that all the rap songs are about her, cause their searching for the queen. And...

Q. Okay.

A. And she says things like if they would just know that I'm being held at Bay County Jail, they'd come and get me. And she always thinks that every time she goes to court somebody's going to come and hold the van up. Like I went to court with her on October 27th and swore when the sirens went by that ah, here comes

my people, you know. And she makes a joke out of it. She thinks it's funny. She thinks that this is cool. I mean um...she, she does, she'll tell you she's not going to prison. Y'all aren't going to get her; she's going to be another Casey Anthony in a sort of way. She wants the fame. She wants the book written about her. She, she wants it all.

Q. Okay.

A. And um...it-it-it's disgusting because you know, I'm, I guess I could say I'm, I'm not in the same situation by any means. But I am, you know? And it, it just makes me sick, how she's, is about, if that makes sense.

Q. Okay, um...did anything else that is important to her case?

A. Um...not that I can think of. If you, if you had like some questions maybe, maybe it would click to me. But as, as of right now it's about it, um just the fact of...it you know. She-she did, she...

Q. Did her current boyfriend, that she lived with, did she say anything about him and having...

A. Zach?

Q. Yeah, having anything to do with...

A. No, no Zach um...Zach did not. Zach um, Zach knew something was wrong she said. Um...he, I guess she told him that she sent the boy to his aunts house. And um...obviously Zach knew that wasn't the case or whatever. And he kept seeing her go back and forth from the back of the house where the water was and um...and um...he was curious what she was doing. So that's when he walked back there. And ah she said that he was worried about what she would do to him and his mom or something like that. So um he told her that that's why he went and got help before he even mentioned it to her and then that's whenever she said, he said, um what did you do? And she's like its okay I can fix it. And he was like you cannot fix this. What did you do, you know? And she was like, I can fix this. And so um no, absolutely not.

Q. Did she give a time frame on when this happened to when she was arrested?

A. Um she, okay um, I asked her if they had Christmas?

She said she knows that it was after Christmas, um, cause she said they had ah tree and um...she said she actually didn't remember what date she killed him. But she knows that she was arrested on the 30th. So she's going from the 25 to the 30th thinking um... in that time frame that I know that after he was dead, she did numerous things. Like she went to Winn Dixie and got alcoholic beverages. Her and Zach um and they were drinking. Not celebrating, I'm not trying to say that. Cause I, Zach didn't know at this time. She was just kind of know knowing what the hell to do. So I know there was a time frame. Um...that I would say like day, like two days possibly at the most. But um I, she didn't say like night time, day time. Or any specific date. She really doesn't know what day she, she told me she

didn't know what day she killed him. She just knows that she was arrested on the 30th and that they had Christmas.

Q. Did she...um...say that she hid anything or did anything with anything that we haven't recovered yet?

A. Um...no. Um she said that y'all real interested in her um, her religion and her books. Like the books that she was reading and stuff. And um, she, she says like how dumb y'all are. That y'all are looking in the wrong, you know y'all are looking in the wrong direction. And um...she was given those books. And the books that, I don't even know what they are. But the books that y'all are talking about don't have nothing to do with what she did and why she did it. And stuff like that.

Q. Did she say where she put the knife that she used?

A. Uh-huh, no.

Q. No?

A. Uh-huh, no not at all. Um I would have been like...

Q. Okay.

A. But um she did say that ah y'all have the cause of death wrong. And um there is no way y'all are going to be able to convict her, when y'all don't even know the way that she killed him.

Q. Had she told you...?

A. She told me that. that that's whenever it went to, she's like um... Later on, I started in March with her and the last month would have been like May. So um after seeing her attorney and stuff she...basically tried to come up with reading her discovery knowing what y'all know and everything that she said that um she's going to switch it around. And basically make it like um...he hurt himself with a knife. That's what she wants her defense to be, because I guess um...it's noted that he had went into the kitchen, she was a bad mom. You know, she, he was getting a hold of knives and stuff like that. She said that because um...it's documented that he was stabbing furniture and wilding out and alone and stuff like that. Um that she was just going to say it was a boo boo that he made on himself. And ah she freaked out as his mom she didn't know how to help him. So that's when she drown him. That she took him out of his misery basically. But she didn't cause the stab wounds. She you know...?

Q. But she's told you that she sacrificed him?

A. Yes she did, yes.

Q. Okay.

A. She...

Q. So this is just a defense she's trying to come up with?

A. A defense that she, she thinks that, she's going to come...She knows that their seeking the death penalty. And um... she-she hasn't really said that she's scared of it or anything. But really she just wants to see how far she can get off it.

(Inv. Chance):

Q. She also stated that the stabbing actually didn't initially kill the baby, is that correct?

A. Right.

Q. She said that drowning the baby was what killed him?

A. Exactly. She said that he was suffering, is her exact words. He was um, suffering from the stab wounds. And she, I guess to put him out of his misery. I don't, I hate to even say those words. But that's how...

(Sgt. Higgins):

Q. Right.

A. That's how it is, that's what she said.

Q. All right, um is there anything else you want to add or take away from this statement?

A. Nah that's it.

Q. Is everything you said been the truth?

A. Yes sir, all of the above.

Q. State your name as if you're signing statement?

A. Tiffany Marie Powell.
