- 4. Meyer and Palin had a relationship and were engaged to be married until May, 2015. Meyer believes that he is the biological father of the minor child.
- 5. Sailor Grace Palin has lived in Alaska since her birth on December 23, 2015 and continues to reside with Palin in Wasilla, Alaska.

- 6. The court has jurisdiction of this matter and venue in this court is proper.
- 7. No custody order involving the child has been issued in Alaska or in any other state.
  - 8. Meyer and Palin have never been married.
- 9. It is in Sailor Grace Palin's best interest for the biological parents to share joint legal custody of the child.
- 10. It is in Sailor Grace Palin's best interest for the biological parents to have shared physical custody.
  - 11. Child support should be ordered in accordance with Alaska Civil Rule 90.3.
- 12. Each parent should be permitted to claim the minor child as a dependent for income tax purposes on alternating years.

## WEREFORE PLAINTIFF SEEKS THE FOLLOWING RELIEF:

- a. A decree of joint legal custody and shared physical custody of Sailor Grace Palin;
  - b. That child support be awarded in accordance with Rule 90.3; and
