CRIMINAL COMPLAINT

Complainant, John Luetscher, an Assistant District Attorney, being first duly sworn on oath, deposes and says that:

Count 1: DISORDERLY CONDUCT

The above-named defendant, on or about Monday, October 14, 2019, in the City of Green Bay, Brown County, Wisconsin, while in a public or private place, at Lambeau Stadium, did engage in abusive, boisterous, indecent, profane, unreasonably loud, violent or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

Count 2: RESISTING AN OFFICER

The above-named defendant, on or about Monday, October 14, 2019, in the City of Green Bay, Brown County, Wisconsin, did knowingly resist an officer, while such officer was doing an act in an official capacity and with lawful authority, contrary to sec. 946.41(1) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 3: ATTEMPT BATTERY TO A LAW ENFORCEMENT OFFICER

The above-named defendant, on or about Monday, October 14, 2019, in the City of Green Bay, Brown County, Wisconsin, attempted to intentionally cause bodily harm

to Craig D Carlson, a law enforcement officer, without their consent, and at the time of the act, the defendant knew or should have known that Craig D Carlson was a law enforcement officer and the act was in a response to any action taken by a law enforcement officer in an official capacity, contrary to sec. 940.203(2), 939.32 Wis. Stats., an attempt to commit a Class H Felony, and upon conviction may be fined not more than Five Thousand Dollars (\$5,000), or imprisoned not more than three (3) years, or both.

Count 4: ATTEMPT BATTERY TO EMERGENCY RESCUE WORKER

The above-named defendant, on or about Monday, October 14, 2019, in the City of Green Bay, Brown County, Wisconsin, attempted to intentionally cause bodily harm to an emergency medical responder, or an ambulance driver who is acting in an official capacity and who the person knows or has reason to know is an, an emergency medical responder, or an ambulance driver, by an act done without the consent of the person so injured, contrary to sec. 940.20(7)(b), 939.32 Wis. Stats., an attempt to commit a Class H Felony, and upon conviction may be fined not more than Five Thousand Dollars (\$5,000), or imprisoned not more than three (3) years, or both.

Count 5: DISORDERLY CONDUCT

The above-named defendant, on or about Monday, October 14, 2019, in the City of Green Bay, Brown County, Wisconsin, while in a public or private place, at Aurora Hospital, did engage in abusive, boisterous, indecent, profane, unreasonably loud, violent or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

Complainant is an Assistant District Attorney with the Brown County District Attorney's Office and knows of the above offenses on information and belief based upon:

PROBABLE CAUSE:

The complainant, being duly sworn on oath, swears that he has had the opportunity to review the police reports from Deputy Carly Resch of the Brown County Sheriff's Office and Officers Matthew Dunn and Scott Asplund of the Green Bay Police Department, and other documents supporting this complaint referenced herein, which are the types of reports and documents kept in the ordinary course of business, which complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

The complainant further asserts that based upon his review of the referenced reports and/or supporting documents, the incidents alleged occurred in the City of Green Bay, Brown County, Wisconsin.

1. The report of Deputy Resch indicates the following:

On Monday 10/14/19, I Deputy C. Resch #1342 was working security for Delaware North at 1919 Kitchen and Tap located inside Lambeau Field (1265 Lombardi Ave., Green Bay, WI, Brown County). I was in my full duty uniform that I wear when I am working as a patrol officer for the Brown County Sheriff's Office. At approximately 9:45 p.m., I was made aware that unarmed security officers from 1919 Kitchen and Tap were out with two subjects near the bar area who were refusing to leave.

I walked over to the bar area and observed one of the security staff speaking with two males at the west side of the bar; Deputy A. Arts #1346 was also working for Delaware North and assisted me in approaching the two males. As we walked up to the males, one of them was yelling at the security officer telling him this was "bullshit" and that he didn't understand why he was being kicked out. This male was later identified, as Ethan J. Lindguist (DOB 01/13/93). It should be noted it is Delaware North's policy that their server/bartender staff not serve anyone they feel has had too much to drink. I stepped in the conversation and tried to explain Delaware North's policy to the male but he continued to speak over me and yell at officers. I tried again to explain to Ethan that I was not sure why they would not serve him but at this time he needed to leave. Ethan then turned to the security officer and myself and yelled, "fuck you!". Ethan also displayed the middle finger and continued to yell obscenities but did start leaving the restaurant.

I followed Ethan out of the restaurant to make sure he left and did not cause a further disturbance out in the atrium area of Lambeau Field. As Ethan was walking away, he continued to shout obscenities loud enough that people from all areas of the atrium started looking in our direction. Ethan was stating things like "this is bullshit", "fuck you", and "I just wanted a fucking shot". Since Ethan was still not calming down and was causing a further disturbance after calmly being asked to leave, I decided the best course of action would be to eject Ethan from the stadium. Ethan was clearly violating the rules of Lambeau Field by yelling obscenities and causing other people to be disrupted in the atrium.

As I was walking behind Ethan, I told him I would now be escorting him out of the stadium due to his behavior. Ethan continued to walk away from me and I told him to stop several times. Ethan continued to yell over me stating he was not leaving and started walking away at a fast pace. When I caught up to Ethan, I placed my hand on his shoulder in order to stop him from walking further away from me. Ethan spun his body around and I held onto his arm in order to control him. Deputy Arts came and grabbed Ethan's other arm and I verbally instructed Ethan to place his hands behind his back. Ethan continued to resist officer's attempts to place his hands behind his back and at one point grabbed onto my wrist. I was able to get Ethan to let go of my wrist but could still not get his hands behind his back. While Ethan was resisting, he was yelling loudly to let go of him and that he did not do anything wrong. One of the other unarmed security staff members assisted Deputy Arts and I with decentralizing Ethan to the ground so we could attempt to handcuff him. At this point, Ethan was becoming extremely combative with officers to the point three of us were not able to secure Ethan in handcuffs.

I used my portable radio to call Captain Sandberg and informed him that we were actively fighting with a male in the atrium. A very short time later, several officers from Green Bay

Police Department (GBPD) arrived on scene to assist with getting Ethan into custody. Deputy Arts handcuffed Ethan behind his back. After Ethan was handcuffed, he started kick at officers. Two GBPD officers were able to secure Ethan's feet while others secured Ethan's right arm and head while I secured Ethan's left arm and wrist. While Ethan was on his stomach in this position. I tried to calm Ethan down by telling him to breathe and that if he would start to relax and cooperate we would speak with him. Ethan had been yelling at officers the entire time we were trying to gain control of him and continued to yell for the remainder of my contact with him. Ethan told officers several times that he wished we would all die and "get shot in the face". Ethan called officers several names such as "cunt", "bitch", "pieces of shit", "mother fuckers" and several more names that are vulgar. I did explain to Ethan why he was being arrested and informed him he would be brought to the Brown County Jail on a charge of disorderly conduct and now resisting. I explained to Ethan several times what he had done to cause this situation but he continued to say he had no idea why he was under arrest.

2. The report of Officer Dunn indicates the following:

On 10/14/2019, I was working at the Lambeau Field. I was working the upper concourse and walking doing a security check in the US Cellular deck. I looked over the railing down into the main level of the atrium and observed two County Deputies appearing to restraining a male on the ground in the atrium. I moved as fast as I could through the crowd from the upper deck down to the main floor of the atrium to assist. At that point, I made contact with Deputy Resch and the other deputy I did not know. They had a male later identified by his Michigan driver's license as Ethan James Lindquist (01/13/93) on the ground and in handcuffs. Ethan was yelling and screaming profanities stating, "Fuck all of you." Ethan attempted to tuck his knees under his body and also attempted to kick the other deputy. Other officers arrived after I called for assistance and assisted in restraining Ethan on the ground. Ethan was constantly very vulgar, swearing and using extremely loud profanities in the middle of Lambeau Field atrium which is filled with additional people, as well as children walking by. Ethan stated numerous times that he didn't know why he was under arrest despite officers telling him he was under arrest for disorderly conduct. Ethan stated he believed he was under arrest for, "Buy a fucking drink." He directed several vulgar slurs at Deputy Resch, calling her a, "Cunt," and telling her to, "Eat a dick." I requested the gator to transport Ethan to the police room for transport out to jail on the charges of disorderly conduct, resisting arrest, and unlawful conduct at a public event. The entire time we were waiting for the gator to arrive, Ethan continued to swear, direct insults at officers and would occasionally pull against officers trying to get his legs free or arms. Whenever, he was begin to tense and I felt resistive tension throughout his body I placed a mandibular angel pressure point on Ethan's left side of his jaw, as his right side of his face was against the floor. Ethan had a friend who was also with him at the game who was standing very close to us despite being asked to step back. Eventually, Officer N. Walvort asked this male to step back and ultimately that male was also arrested.

Once the gator transport vehicle arrived, Ethan was placed in the wrap restraint system.

Ethan was carried and placed in the back of the gator transport vehicle as we drove him down to the police room. The entire time, Ethan continued to yell as we were driving through the crowded Lambeau Field atrium, full of adults and children alike. He stated several times,

"Fuck all the police." I also heard Ethan several times direct threats at Officer Craig Carlson saying, "I'll fucking kill you." When we stopped at one point to adjust Ethan's position, so he did not hit his head on the doorway as we were going through, I observed Ethan attempting to bite Officer Carlson's leg, as he moved his entire face towards Officer Carlson's ankle and opened his mouth as wide as he could. At that point, I stabilized Ethan's head against the tailgate of the gator so he could not bite officers.

Eventually, we were able to reach the police room and Ethan was loaded in the back seat of Officer Asplund's patrol vehicle for transported to the Brown County Jail. I began completing the citations regarding Ethan's violations today.

3. The report of Officer Asplund indicates the following:

On 10-14-19 at 10:07 PM I was working as a transport car at Lambeau Field when I heard on the radio officers were calling out with subject resisting arrest and a short time later requesting a wrap device to safely transport the male. I arrived at about 10:20 at the sally port are of Lambeau when I was told I would be transporting the male to jail.

The male was still in the wrap and was screaming at the top of his lungs at officers making comments about officers dying. It took a few minutes to get the male, Ethan Lindquist, in the back of my car because of his size and him not assisting in getting in the back of the car.

Brown County Officer Resch was the arresting officer and she said she would ride with me in my car so she sat in the passenger seat while we drove to the Jail. During the entire way to the jail Ethan was screaming at officers. I would guess he called Officer Resch a cunt at least 150 times. She may have recorded the audio of the ride, refer to her recording for additional information. He also called me profanities and told us both numerous times how we wish we would die and how he hopes we suffer while dying. On two occasions just before arriving at the jail he started pounding his head violently against the plastic divider. We yelled for him to stop but he didn't. We realized after the second round of violent head pounding he was bleeding heavily and I requested EMS respond to the sally port with an additional officer.

The male was not cooperative with EMS but needed to be transported for stitches. He was put in the ambulance while still having on the wrap system. Because of the large amount of blood a spit hood was placed on him. He was screaming at fire fighters on the ride and harassing them calling them vulgar names. At one point he screamed to them "I'm going to fucking bite one of you", "I'm going to bite you fucking so hard". A short time later he violently lifted his legs up and tried to kick the fire fighter that was located by his feet. He came close to kicking him but missed. The fire fighter was identified as Micah C. Roddy. Fire Fighters and I had to physically restrain his legs so he couldn't attempt to kick at them any more. Listen to audio recording labeled "Interview 004" for what happened in the back of the ambulance.

Once arriving at ABMC he continued to scream. Listen to audio recording labeled "Interview 005" for what he did at the hospital. He continually screamed vulgarities as loud as he could inside of the ER forcing other patients to have to be moved and disrupting the ER. After he was treated EMS refused to transport him back to jail, so it was decided to put a helmet on him and try to transport again. Ethan was disrupting the hospital for approximately 30-45 minutes, possibly more.

Based on the foregoing, the complainant believes this complaint to be true and correct.
