Dear Landowner,

We invite you to attend a series of "Partnering for Watershed Restoration of Lake Superior" forums in 2018 for the western Upper Peninsula of Michigan (UP). These presentations and workshops will offer an in-depth look at on-the-ground restoration, land management, and wildlife improvement activities and options for forests and wetlands. Your attendance at one or more of these workshops will give you an excellent opportunity to learn about financial assistance options and connect with technical services provided by the Natural Resource Conservation Service (NRCS), Michigan Department of Natural Resources (MDNR) and Michigan Association of Conservation Districts (MACD) offices and staff members. Whether you seek to manage your private land for timber, wildlife, recreation or all of the above, this workshop can lead you to the resources to help make that happen.

These workshops will explain how implementing a resource management plan can: enhance habitat for birds such as the golden-winged warbler, woodcock and ruffed grouse, improve habitat for black bear and white-tailed deer, encourage populations of bees, monarch butterflies and other pollinators, improve conditions for popular fish species such as brook trout, provide enrichment ideas for recreation and assist with reducing wildfire threats to your forest.

This forum is another interagency effort that includes the Michigan Department of Natural Resources, US Forest Service, Conservation Districts and the Natural Resource Conservation Service. We strive to inform private landowners about funding sources to develop resource management plans and assist with implementing practices to improve forest health and wildlife habitat on their land.
