On or about August 7, 2018 in St. Joseph County, State of Indiana, ANDREW STEINKE, being at least eighteen years of age, to-wit: with a date of birth of [REDACTED] 1990, and a child care worker for O.T., a child at least sixteen years of age, but less than eighteen years of age, to-wit: with a date of birth of [REDACTED] engaged in sexual intercourse, with said child with the intent to arouse or satisfy the sexual desires of either ANDREW STEINKE or O.T.

All of which is contrary to the form of the statutes in such cases made and provided by I.C. 35-42-4-7(m) and I.C. 35-42-4-7(q)(2), and against the peace and dignity of the State of Indiana.

I affirm under the penalties for perjury that the foregoing representations are true.

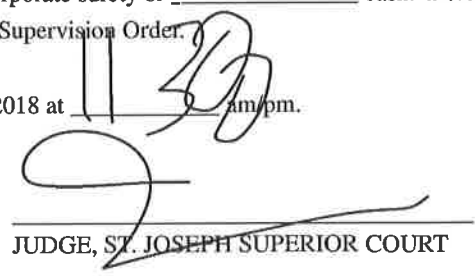

Detective David Leda affirms under the penalty of perjury and states:

I am a Detective with the Special Victim's Unit in St. Joseph County, State of Indiana, and make this affidavit after reviewing information from other law enforcement officer's reports, Special Victim's Unit investigations, interviewing various witnesses, as well as the criminal history for the DEFENDANT. All events occurred in St. Joseph County, Indiana. I make this affidavit based upon those reports.

On August 7th, 2018, I was assigned to an investigation involving Child Seduction to a O [REDACTED] T [REDACTED] DOB: [REDACTED] 2001 referred to as (OT) hereafter by a ANDREW L. STEINKE.

On August 6th, 2018 a report was made to the Department of Child Services about an anonymous tip that was sent to the [REDACTED] High School principal (Mansour Eid). The tip was in reference to a substitute Teacher/ assistant football coach (ANDREW L. STEINKE) at Clay High School who was having some type of relationship with (OT).

On August 7th, 2018 I interviewed (OT). (OT) stated that she had been in a relationship with ANDREW STEINKE since October of 2017. (OT) said she knew ANDREW STEINKE was a substitute teacher / assistant football coach at the school. (OT) said that she and ANDREW STEINKE began having sexual intercourse in December of 2017. (OT) stated that she and ANDREW STEINKE would hang out at his house on Helmen in his bedroom watching

movies and talking. (OT) said she wasn't sure of the address but it was a yellow house. (OT) said that in December she and ANDREW STEINKE started to make out and it progressed to them having sex. (OT) stated that ANDREW STEINKE asked her and she said it was fine and she lost her virginity on that night. (OT) said that she would see ANDREW STEINKE in the hallways at school and she would avoid looking at him because she did not want to give away the fact that they were dating. (OT) said that she and ANDREW STEINKE had sexual intercourse approximately 10 times. (OT) stated that the relationship lasted until May of 2018. (OT) said that she broke the relationship off because ANDREW STEINKE became obsessed with her. (OT) had text messages on her phone from phone number [REDACTED] that were in reference to a relationship between (OT) and CHEATER (this is how (OT) had ANDREW STEINKE listed in her cell phone).

On August 7th, 2018 I called ANDREW STEINKE by calling [REDACTED]. He agreed to come in to the Special Victim's Unit for an interview on August 9th, 2018 at 10:00am.

On August 9th, 2018 ANDREW STEINKE arrived at the Special Victim's Unit at 10:00am and he was escorted to an interview room. It was explained to ANDREW STEINKE that he did not have to talk to me or answer any questions. I had a Waiver of Rights form and I read the top portion, Warning as to Rights, to ANDREW STEINKE. ANDREW STEINKE read the bottom portion, Waiver of Rights aloud, and he stated he understood. ANDREW STEINKE read and signed the form agreeing to talk with me.

During the interview ANDREW STEINKE first denied having any relationship with (OT) because he was in a position of authority and it would be wrong. ANDREW STEINKE stated that he knew who (OT) was and they had talked. ANDREW STEINKE stated that he was the good-looking teacher and football coach so kids start rumors. After being confronted about

the rumors and the fact that (OT) had already been interviewed ANDREW STEINKE changed his story. ANDREW STEINKE said he and (OT) started talking around October of 2017. ANDREW STEINKE said he and (OT) would hang out at his house [REDACTED] South Bend, Indiana) and just talk. ANDREW STEINKE stated that things just progressed and they began having a sexual relationship. ANDREW STEINKE said he and (OT) started having sexual intercourse around December of 2017. ANDREW STEINKE said he didn't mean for him and (OT) to have sex it just happened. ANDREW STEINKE said he and (OT) had sexual intercourse approximately 5 times. ANDREW STEINKE stated that the relationship ended in May of 2018.

All of the above events occurred in St. Joseph County, Indiana.
