Christopher C. Fronk, being duly sworn upon his oath, says that:

I am Chief Deputy Prosecuting Attorney with the 60th Judicial Circuit, St. Joseph County, State of Indiana, and make this affidavit after reviewing The investigation of Metro Homicide and personal observations.

On January 26, 2020 at about 12:43 pm South Bend police were alerted to a shooting at 610 S. Liberty Street, South Bend, St. Joseph County, IN with at least one party down. On arrival, officers found one male, later identified as Huey Hudson, Jr. age 28, deceased with apparent gunshot wounds.

The victim's brother, Marquise Scott, was present in the home, as was Timothy Ross, and both were transported to Metro Homicide for questioning. Numerous spent shell casings and live rounds were visible on scene. A strong odor of marijuana permeated the air within the house, and several liquor bottles were out and open in the area of the victim. Several apparent bullet defects could be seen passing through walls in the home.

MHU conducted interviews of M. Scott and T. Ross, as well as Troy "TJ" Scott, Jr., Brian Scott, and Tristan Gill-all of whom were present when the shooting took place. It was learned that this shooting was related to a shooting that happened earlier in the evening. The home is the property of Marquise Scott, and owned by his family. Marquise Scott is the brother of Huey Hudson, Jr. Throughout those interviews a suspect was identified as Troyon "Fatty" Scott.

Troyon "Fatty" Scott had arrived at the home with his two brothers, Troy "TJ" Scott, Jr. and Brian Scott. They were invited guests of Marquise Scott and were drinking and hanging out. Huey Hudson, Jr. later called and talked to his brother Marquise, and informed him that their cousin DeMarco Barnes had been shot by another one of the brothers of Troyon "Fatty" Scott at another location earlier in the evening. Hudson learned

that the Scott brothers were in the home, became angry and came over to Marquise's house.

When Hudson arrived he was armed with a handgun and yelled at the Scott brothers, in turn, about the shooting by their brother. Hudson may have threatened the Scott brothers. The last Scott brother Hudson yelled at was Troyon "Fatty" Scott. While the two men were face to face, shots rang out. All the witness claim that they tried to flee the residence as the shots were being fired.

Ballistic testing on the shell casing recovered from the home reveal that all of the shell casings on scene were fired by a single firearm. Autopsy confirmed that Huey Hudson, Jr. died as result of multiple gunshot wounds, in particular-two wounds to the left back of his neck that took an upward path through his neck and head and exited in and near Hudson's right ear. Hudson also sustained a non-fatal gunshot wound to each shoulder.

DETENTION CONSIDERATIONS

The Defendant is charged with murder.

WHEREFORE, the State requests that the Court order the Defendant held without bond.

I affirm, under the pains and penalties for perjury, that the foregoing representations are true.
