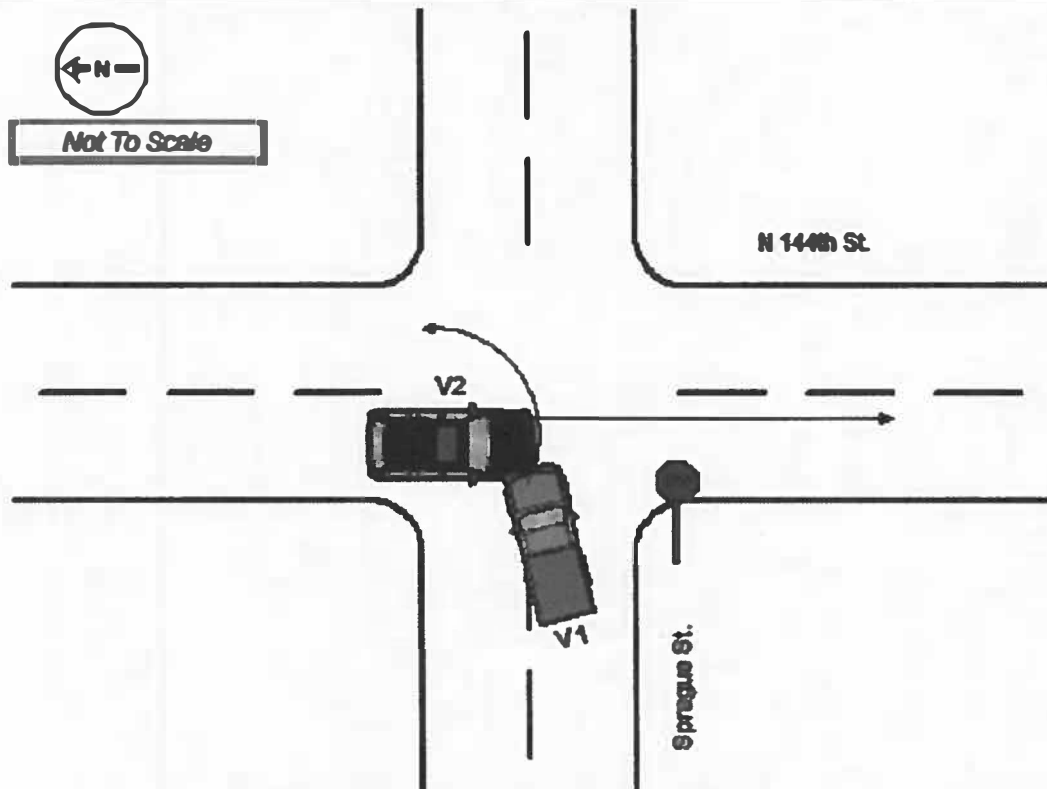

## DESCRIPTION OF ACCIDENT BASED ON OFFICER'S INVESTIGATION

On MON 02 SEP 19 at 1841 hours R/O SHEETS #2414 and DIBIASE #2316 were dispatched to N 144th St and Sprague St for report of a personal injury accident involving a child.

Upon arrival Officers spoke with the driver of Vehicle 2 EICHER, Bryan W/M [REDACTED] who stated that he was going Southbound on N 144th St when the driver of Vehicle 1 pulled out in front of him to turn North onto N 144th St. EICHER stated the driver was a male and was intoxicated. EICHER stated that the male driver got out of vehicle 1 to see if they were ok in Vehicle 2 and EICHER stated that the female passenger who was sitting in the center of Vehicle 1 moved over into the drivers seat and eventually backed the Vehicle up off the roadway. EICHER stated that the male driver of Vehicle 2 came up to him and stated that he was a suspended driver and had been drinking.

Officer DIBIASE spoke WERTH, Doug W/M and began to perform an HGN, when he then informed Officer that he was not the driver and pointed to the Female sitting in the driver seat. Officer DIBIASE then spoke with the driver of Vehicle 1 FARIS, Tammy W/F who stated she was driving Vehicle 1 and turned left onto N 144th St. to go northbound and truck Vehicle 2.

Officer SHEETS had FARIS get in the driver seat to check the seatbelt sizing to observe if it was loose when it buckled and observed that it was not loose.

Officer DIBIASE checked WERTH for any premature bruising from the seatbelt on his left shoulder from the impact of the accident. R/O observed no bruising.

FARIS was cited for failing to yield turning left.

BWC available.

Medics 78 on scene to check the well being of the children in the backseat of Vehicle 2.  
No injuries reported at time of incident.

SGT RICKER #1806 advised.

No witnesses present at time of accident.
