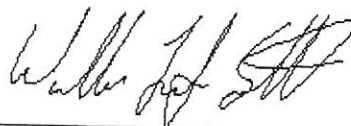

AFFIDAVIT

Personally came **William Smith**, who on oath says that to the best of his/her personal knowledge and belief, **Mary Katherine Smith** did, on **Jul 30, 2014** at approximately **09:00 PM** in Richmond County, Georgia, commit the offense of: **CRUELTY TO CHILDREN IN THE SECOND DEGREE - Felony** in violation of **O.C.G.A 16-5-70.A**, a **Felony** under the laws of the state of Georgia, in that said accused on the above stated date and time, **did, with criminal negligence cause a child under the age of 18, namely: [REDACTED] he being 2 years old, excessive physical pain.** The accused picked said victim up and began to shake him back and forth followed by slapping him in the face in an attempt to revive him because he has **Breath Holding Syndrome (BHS)**. Said accused allowed said victim to lie on the bed while he was unresponsive for around three (3) hours before seeking medical attention. Said victim was admitted to **Georgia Regents University** and the medical staff revealed that he is suffering from **retinal hemorrhaging behind both of his eyes, minimal brain activity, healing rib fractures on his right side, herniating bleed on the left side of his brain and his pupils were fixed and dilated.** Said accused is a registered **Licensed Practical Nurse (LPN)** and based on her medical training and experience should have gotten said victim medical attention immediately. This offense occurred at **[REDACTED] in Augusta, Richmond County, Georgia.**
