COMPLAINT

Now comes TODD FELTZ, Plaintiff herein, who shows as follows:

1. Wayne Player, herein First Defendant, is a resident of the State of Florida and may be served at 144 Gulfstream Drive, Tequesta, Florida 33469. Defendant committed a tortious act within this County and is subject to the jurisdiction of this Court pursuant to O.C.G.A. §9-10-91.
2. Wayne Player Enterprises, LLC, hereinafter Second Defendant, is a foreign corporation. Second Defendant, in concert with First Defendant, committed a tortious act within this County, has transacted business within the County and is subject to the jurisdiction of this Court. Pursuant to O.C.G.A. § 9-10-96, Second Defendant may be served through its registered agent Wayne Player at 144 Gulfstream Drive, Tequesta, Florida 33469.
3. At all times herein, First Defendant acted as an agent of Second Defendant.
4. On or around October 2, 2017, Defendants and Plaintiff entered into a contract whereby Plaintiff would receive hospitality services and access to the Masters Golf Tournament in Augusta, Georgia. The services to be provided are fully described in the memorandum

attached as Exhibit "A".

5. When Plaintiff arrived in Augusta to attend the Masters Tournament , it became apparent that Defendants could not perform the contract. Plaintiff approached First Defendant to discuss issues surrounding the non-performance of the contract.

6. During the discussion, First Defendant became angry and intentionally made physical contact with Plaintiff by head butting him and knocking him to the ground. This conduct constitutes an actionable battery.

7. Defendants failed to perform the services described in Exhibit A thereby breaching the contract between the parties. As a result of breach, Plaintiff has suffered damages.

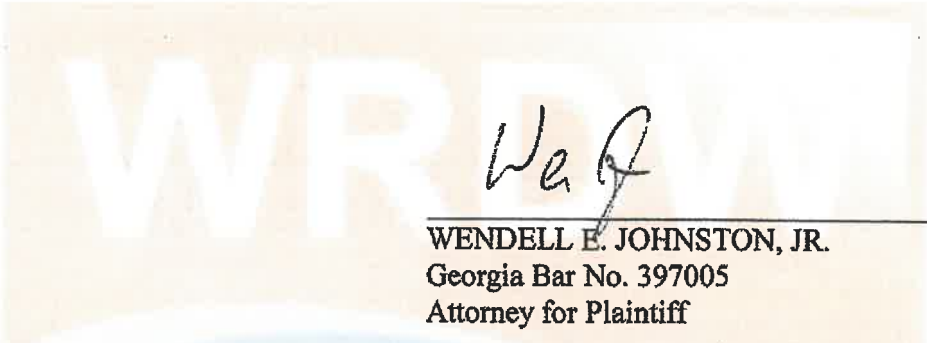
8. Defendants have been stubbornly litigious, has acted in bad faith and/or has caused Plaintiff unnecessary trouble and expense. Plaintiff is thereby entitled to attorney's fees pursuant to O.C.G.A. § 13-6-11.

9. Plaintiff is entitled to punitive damages due to the intentional battery committed by First Defendant.

- c) damages for battery;
- d) attorney's fees pursuant to O.C.G.A. § 13-6-11;
- e) punitive damages; and
- f) for such other relief deemed appropriate by this Court.

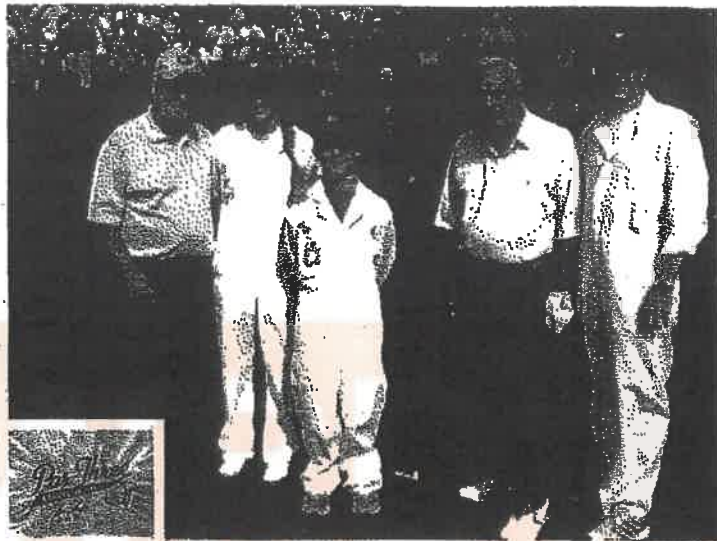
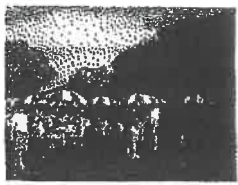
