Press Release – Village of Weston Narcotics Arrests/Search Warrant

March 13, 2017

The Everest Metropolitan Police Department in conjunction with the Marathon County Sheriff's Office, Special Investigations Unit (SIU) - comprised of investigators from Marathon County Sheriff's Office, Everest Metro PD and the Wausau Police Department made several arrests in connection with recent investigations into local methamphetamine distribution and a high volume of methamphetamine arriving in the Village of Weston from Minnesota Thursday morning, March 9, 2017.

In the culmination of two traffic stops and the execution of a search warrant at a home in the 4300 block of Schofield Avenue - Weston, the investigation resulted in the seizure of approximately 237 grams (1/2 pound) of methamphetamine with an approximate street value of \$23,500.00. Also seized were suspected MDMA tablets, numerous items of drug paraphernalia and over \$1,700.00 in United States currency.

Three individuals: Casey T. Graham (34) - Weston, Rebecca M. Torgerson (36) - Weston, and Mee N. Vang (32) – Minneapolis, Minnesota are currently in custody at the Marathon County Jail awaiting court proceedings in connection with the investigation. All will face various criminal charges and a request for prosecution of these individuals has been forwarded for the review of the Marathon County District Attorney's Office. The criminal charges requested include but are not limited to:

- Possession with Intent to Manufacture, Deliver or Distribute Methamphetamine
- Delivery of Methamphetamine
- Possession of Drug Paraphernalia
- Maintain a Drug Trafficking Place
- Maintain a Drug Trafficking Vehicle

Rebecca Torgerson also had two active warrants issued for her arrest, one by from the Oneida County Sheriff's Office for Contempt of Court for Operating with a Restricted Controlled Substance. The second was a felony warrant issued by the Wisconsin Department of Corrections (WI DOC) for Torgerson's violation of her parole supervision.

Rebecca Torgerson and Mee Vang may face probation/parole sanctions for their arrests and involvement in this investigation. Torgerson is currently under the active parole supervision of the WI DOC – Division of Community Corrections (Rhineland) for Possession with Intent to Manufacture, Distribute or Deliver Methamphetamine and Cocaine, Possession of Drug Paraphernalia, and Felony Bail Jumping. Mee Vang is also currently under the active parole supervision of the WI DOC – Division of Community Corrections (Wausau) for Possession with Intent to Manufacture, Distribute or Deliver Methamphetamine and as a Convicted Felon in Possession of a Firearm.
