NARRATIVE

BRIAN MURPHY ARRESTED FOR OPERATING VEHICLE UNDER THE INFLUENCE OF ALCOHOL OR DRUGS - OVI 4511.19A1A, MURPHY WAS LODGED IN THE WCJC

On 12/21/17 dispatch advised Toledo Police Department had a vehicle stopped at the Holiday Inn Express at 2150 E. Wooster St. Bowling Green Ohio. Dispatch advised they were requesting a Bowling Green Police Division officer to respond. I arrived and spoke with Officer BASLONE (2574) and Officer KRABILL (2569) assigned to unit 422. They said they were en route to the Wood County Justice Center when they observed a vehicle make a marked lanes violation and drive onto the median on the I-75 overpass on E. Wooster St. They said as they continued to drive they observed more unsafe marked lanes violations. They said they were concerned for the public safety and initiated a traffic stop.

The vehicle was a black Honda Pilot with a registered plate of HEV2736 registered to the operator BRIAN MURPHY. MURPHY was stating outside his vehicle with one of the officers when I arrived. I initiated the camera in vehicle 109 and spoke with MURPHY. MURPHY advised he was coming from Toledo and when I asked where he said downtown. I asked him where he was headed and he said home. MURPHY advised he lived in Maumee. I asked him if he just was just visiting Bowling Green and he seemed confused of where he was. I asked him how much he had to drink and he said a couple. I asked if he meant a couple beers or shots and he said a couple beers.

MURPHY'S eyes were red, blood shot, and watery. He had the odor of an alcoholic beverage coming from his person. His clothes had the faint odor of vomit. MURPHY'S speech was slow and slurred and hard to understand. He was very unsteady on his feet, swayed, and continually almost lost his balance. I performed Standardized Field Sobriety Tests on MURPHEY in the parking lot after ascertaining he was not taking any prescribed medication nor had any health issues. I observed six indicators on the Horizontal Gaze Nystagmus. MURPHY was unable to complete the Walk and Turn. MURPHY was unable to complete the One Leg Stand and I had to terminate it due to fear of him falling and sustaining an injury. I placed MURPHY under arrest and transported him to the Bowling Green Police Division.

At the Bowling Green Police Division I read MURPHY the BMV2255 with Dispatcher Trent Tatham as a witness. MURPHY became irritated when he had to sign that he was read the form. I continually explained what he was signing and he did not believe or understand me. He eventually signed it; however, it took such a long time that the machine froze. MURPHY advised he was not going to submit to the intoxilyzer 8000 test. I asked if he was refusing and he said yes. I reset the intoxilyzer 8000 and made multiple efforts to explain the states imposed penalties for refusal in answer to MURPHY`S questions. When it came time for MURPHY to sign again he became even more agitated and aggressive. He squared his body towards me and leaned in so that his face was only a few inches from me. He raised his voice and tensed his muscles. He then threw the stylus and said he was not signing and cursed.

Because of his aggressive behavior I attempted to place MURPHY in handcuffs. When I gained positive control of his right hand he began to turn away and attempted to pull his arm away from my grasp. I maintained positive control of his arm as PTL ROBINSON gained positive control of his left arm and told him to stop resisting. MURPHY said he was not resisting; however, he was still tense and attempting to pull from my grasp. I told MURPHY to relax and he complied and was placed in handcuffs single finger spaced and double locked behind his back.

I had MURPHY sit in a chair as I continued the process with the intoxilyzer 8000. MURPHY was still

agitated and talked about how politics would happen. I reminded MURPHY that he was being recorded and he said he didn't cause because he knew what would happen. He continued to talk about everything he does for "this community" because of his job as the Deputy Superintendent for Toledo Public Schools. I asked MURPHY what town he was currently in and he said Toledo. I reminded MURPHY that he was in Bowling Green and not Toledo. He asked if it was Wood County and I said yes. He said it did not matter because the judge was republican or demarcate and politics would happen. I asked MURPHY to elaborate what that meant and he said that I know what was going to happen at court. ROBINSON transported MURPHY to the Wood County Justice Center.

I contacted an employee at the Holiday Inn Express and told her that the owner of the vehicle that was left in their lot was taken to jail. I advised that it would more than likely not leave the lot overnight. I asked her if it was a problem for it to stay parked in the lot or if they wanted it towed from the lot. She stated that they did not want it in the lot overnight and asked if it could be towed. I completed a Bowling Green Division Tow Sheet and BG Towing collected the vehicle.

I will do follow up as needed.
